COMES NOW, BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25.22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") has issued an Audit Request in connection with the NARUC/FCC Regional Audit of BellSouth. Staff has requested, among other things, that Southern Bell furnish the following information:

Audit Request No. 2-183, dated November 3, 1993 - "Re: BellSouth Headquarters - It is our understanding that BellSouth HQ reduces the annual per foot charge for rental of the Campanile Building from \$24.06 per square foot to \$16.98 per square foot in their allocated overhead calculation, (It is our understanding that the difference is retained by BSHQ). Please confirm the amounts as shown above and provide for the year 1992, the total amount and square footage as billed to BSHQ, and the total amount as allocated as overheads and billed out by BSHQ. information is readily available, please furnish the amount of the "rental expense" that was allocated to Telephone Operations."

3. Some of the information being provided is clearly proprietary. For example, the information being provided contains competitive lease rate information and other costs for office space rental by a non-regulated affiliate company. Such information is specifically considered to be proprietary, confidential business information pursuant to § 364.183(3)(e), Florida Statutes.

4. Consequently, because this information contains proprietary information, Southern Bell is filing this Notice of Intent to Request Confidential Classification, pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Staff to review this information without delay. Both the original of this notice and the individual requests have been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information. The written Staff Requests are attached hereto.
