MOTION TO SUSPEND
CASE ASSIGNMENT AND SCHEDULING RECORD

Applicant, RESORT VILLAGE UTILITY, INC., moves that the Commission suspend the Case Assignment and Scheduling Record ("CASR") in this docket pending disposition of Applicant's Motion to Dismiss and as grounds, therefor, states:

1. The current CASR in this docket (the second revised CASR) calls for Applicant's testimony to be filed August 5, 1994, and Intervenor's testimony to be filed August 26, 1994.

2. Applicant has filed a Motion to Dismiss, which, if granted, would eliminate the need for a hearing in this docket. Commission staff has recommended that that motion be granted. The motion was scheduled to be heard at the August 2, 1994 Agenda Conference but was deferred to August 16, 1994.

3. There is no necessity to file testimony prior to the disposition of the Motion to Dismiss.

WHEREFORE, Applicant requests that the CASR in this docket be suspended pending disposition of Applicant's Motion to Dismiss.


