Service Commission is notified that on this date, West Charlotte  
Utilities, Inc. ("WCU") began providing wastewater service across  
Charlotte and Sarasota County boundaries. Heretofore, WCU has been  
providing service only in Charlotte County and has been regulated  
by the Charlotte County Board of County Commissioners.

Pursuant to Section 367.171(7), Florida Statutes, the Florida  
Public Service Commission now, has regulatory jurisdiction over  
WCU.


