We are still trying to acquire a copy of the system map. I spoke with Ron Hoffer about this matter last week and he told me that he has contacted the Florida Department of Environmental Protection and that they could not locate the map, but that they had an area that contained a lot of old records and that he could come search the records to see if he could locate it. Ron told me that he would go to their office and try to get a copy of the map. Once we acquire it we will send a copy to you

Evidence of Ownership I have been unable to find any other Deeds for the property in Sky Acres name. What I did find is a warranty deed for Amanda Company of Florida Inc. and a warranty deed for Amanda Company Inc. (a Wisconsin Corp.) along with a title Insurance policy for the original purchase in 1981. These are the only documents of ownership that I can find. To help explain, the two corporations and Sky Acres Enterprises are all owned by the same individuals. In 1981 the land was purchased by Amanda Company of Florida Inc. from Fred and Betty Short. Then in 1985 the property in question was transferred to Amanda Company Inc. (a Wisconsin corporation). Then in 1986 the partners decided to dissolve Amanda Company Inc. (a Wisconsin Corp.) and quitclaimed the property to Sky Acres Enterprises. I think that because the property was basically owned by Terry Hoffer and his brothers and sisters in the form of each entity listed that they didn't feel Title insurance was necessary. I have included the documents mentioned above (marked DEEDS) and hope that they will suffice. If they are still not adequate, please let me know what must be done in order to rectify the problem.

The conditions of such application or agreement are binding upon the customer as well as upon the Company. A copy of the application or agreement for wastewater service accepted by the Company will be furnished to the applicant on request.

The applicant shall furnish to the Company the correct name and street address or lot and block number at which wastewater service is to be rendered.

4.0 <u>APPLICATIONS BY AGENTS</u> - Applications for wastewater service requested by firms, partnerships, associations, corporations, and others shall be rendered only by duly authorized parties. When wastewater service is
