PETITION FOR APPROVAL OF ENVIRONMENTAL COST RECOVERY TRUE-UP FOR PERIOD ENDING MARCH 1996

Florida Power & Light Company ("FPL") hereby Petitions this Commission for approval of FPL's final Environmental Cost Recovery true-up amount of \$2,087,436 underrecovery for the October 1995 - March 1996 period and an underrecovery of \$65,778 as the adjusted net true-up amount to be carried forward to the October 1996 through September 1997 period. In support of this Petition, FPL states as follows:

- 1. The final \$2,087,436 Environmental Cost Recovery underrecovery for the period October 1995 March 1996, was calculated in accordance with the methodology set forth in Schedule A-2 for the Fuel Cost Recovery Clause, attached to Order 10093 dated June 19, 1981. This calculation and the supporting documentation are contained in the prepared testimony of FPL witness B. T. Birkett, which is being filed together with the Petition and incorporated herein.
- 2. The adjusted net true-up for the period of an underrecovery of \$65,778 is the difference between the actual true-up of \$2,087,436 underrecovery and the estimated/actual true-up of

\$2,021,658 underrecovery approved by the Commission at the March 1996 hearing.

WHEREFORE, Florida Power & Light Company respectfully requests the Commission to approve the net \$2,087,436 environmental cost recovery underrecovery as the final true-up amount for the period ending March 1996, and an underrecovery of \$65,778 as the adjusted net true-up amount to be carried forward to the period beginning October 1996.
