



Ridge Generating Station

Paragraph 8 of the Settlement Agreement between Ridge Generating Station (Ridge) and Florida Power Corporation (FPC) provides for two payments to be made to Ridge. The first payment of \$1,197,000 represents the difference between the payments made by FPC to Ridge and what the payment would have been under the Settlement Agreement for the period from August 9, 1994 and January 31, 1996. The second payment is for the same difference for the period from February 1, 1996 to February 29, 1996. This second payment is in the amount of \$98,527.23.

Both of these amounts were included in the payment to Ridge for March, 1996 deliveries and were subject to Florida Public Service Commission approval pursuant to the terms of the Settlement Agreement. These amounts were reflected in FPC's A-schedules for the month of April, 1996. Subsequent to Staff's comments on this issue in June, 1996, in the Docket approving the FPC-Orlando Cogen Settlement Agreement, FPC agreed to make a special notation of any future payments that differed significantly from the contractual terms of an FPSC-approved cogeneration contract.
