Dear Mr. and Mrs. Burgman:

Public Service Commission staff has received your letter regarding the possible sale of Glenn's Cove Water System in Lake County. Staff understands your concerns about a possible sale and exit of the system from PSC regulation. It is our understanding that a non-profit homeowners association is negotiating for the purchase of the water system from the present owner.

Should this sale occur, the operation of the water system by the homeowners association would qualify the utility as an exempt entity. This "exempt" status means that the system is excluded from rate base regulation. Such status does have its benefits. The utility system would not be required to pay a yearly regulatory assessment fee, submit an annual report or meet other regulatory measures, which only increase the costs of operating a water utility system. As members of the non-profit association, you would have the opportunity to have input on operation of the system and participate in setting rates and charges. However, even though the association would be an exempt entity, it is still considered to be under the regulatory umbrella of the Commission. If there are abuses in the operation of the utility, the Commission could still initiate an investigation and require the utility to file for certification as a fully regulated utility.
