Friday, June 27, 1997, has also been reserved for continuation of the hearing if needed. The starting time of the next day's session will be announced at the conclusion of the prior day. The hearing may be adjourned early if all testimony is concluded.

PURPOSE AND PROCEDURE

The purpose of this hearing shall be to allow Florida Power Corporation to present testimony and exhibits regarding the nuclear outage at Florida Power Corporation's Crystal River Unit 3; to permit any intervenors and Florida Public Service Commission staff to present testimony and exhibits, if any, concerning this matter; and for such other purposes as the Commission may deem appropriate. All witnesses shall be subject to cross-examination at the conclusion of their testimony. The proceedings will be governed by the provisions of Chapter 120, Florida Statutes, and Chapter 25-22, Florida Administrative Code.

A prehearing conference will be conducted at the following time and place:


