Dear Chairman Johnson:

Thank you for the information regarding the review of the nuclear outage at Florida Power Corporation's Crystal River Unit 3. I appreciate that this issue is being prepared for public hearings, since it will affect some of my constituents and many others in the state.

I am, however, concerned that your letter states that after extensive investigation and the scheduled customer and technical hearings a decision will be made by the PSC, but it has been publicly advertised that the Commission will accept the findings of Florida Power Company as to the reason for the outage instead of conducting their own personal investigation. If indeed this is so, where are the checks and balances in this investigatory phase?

If this is fact I would expect my constituents to ask if all further cases will be conducted in this manner. If so, those who have already pleaded that I propose an alternative to the Commission may have a valid proposal in the minds of the utility customers of the district.

I would be interested in your reply specifically in relation to the details of this particular issue.
