JOINT PETITION FOR THE APPROVAL OF THE CONSOLIDATION OF THE FLORALA TELEPHONE COMPANY, INC., GULF TELEPHONE COMPANY, AND ST. JOSEPH TELEPHONE & TELEGRAPH COMPANY, THE ASSOCIATED TRANSFER OF CERTIFICATES, AND THE CHANGE OF THE NAME OF ST. JOSEPH TELEPHONE & TELEGRAPH COMPANY TO GTC, INC.

Pursuant to Sections 364.33, 366.335 Florida Statutes (1995) and Florida Administrative

Code Rule 25-4.005, St. Joseph Telephone & Telegraph Company, the transferee, and The Florala

Telephone Company, Inc. and Gulf Telephone Company, the certificate holders, hereby jointly

petition for approval of the consolidation of the certificate holders into St. Joseph Telephone &

Telegraph Company, the associated transfer of the Florida Public Service Commission certificates

of public convenience and necessity held by the certificate holders to St. Joseph Telephone &

Telegraph Company, and the change of the name of St. Joseph Telephone & Telegraph Company

to GTC, Inc. In support of this Petition, the joint petitioners state:

The Florala Telephone Company, Inc., Gulf Telephone Company, and St. Joseph
Telephone & Telegraph Company ("Operating Companies") provide local exchange telephone
service pursuant to certificates of public convenience and necessity issued by the Florida Public



Telegraph Company will change its name to GTC, Inc. As part of the consolidation, the certificates of public convenience and necessity held by Gulf Telephone Company and The Florala Telephone Company, Inc. will be transferred to St. Joseph Telephone & Telegraph Company. The consolidation, the associated transfers of certificates, and the name change proposed are purely an internal corporate restructuring; instead of holding the stock of the three Operating Companies, St. Joe Communications, Inc. will hold the stock of one operating company with three local exchange certificates of public convenience and necessity (or one reissued certificate of public convenience and necessity if the Commission so chooses).

- 4. Historically, each of the Operating Companies, all of which serve territories in Northwest Florida, have had their own accounting, personnel, purchasing, engineering, customer service and marketing functions under the direction of local management. There has been little sharing of employees and resources because of the constraints of separate corporate entities. Consolidation of the Operating Companies will allow administrative and operating efficiencies, facilitating the joint use of personnel and resources. This streamlining should enhance the provision of telephone service provided to the customers of the Operating Companies.
- 5. While the administration and operation of the three Operating Companies will be consolidated, there are a number of aspects of the operations of the Operating Companies which will not change as a result of the restructuring. The boundaries of the service areas served by the Operating Companies will not change. Currently, the Operating Companies provide within their respective service areas the services set forth in their Tariffs, which are on file with the Commission and are incorporated herein by reference, and none of the Operating Companies provide service in the service territory of another Operating Company. As of May 31, 1997, the

3. The Operating Companies, which are wholly-owned subsidiaries of St. Joe
Communications, Inc., seek to improve customer service, streamline administration, and improve
operating efficiency by consolidating into a single operating local exchange company. GTC, Inc.
is a wholly-owned subsidiary of TPG Communication, Inc., the parent company of St. Joe
Communications, Inc. To effect the consolidation, Gulf Telephone Company and The Florala
Telephone Company, Inc. will be merged with and into St. Joseph Telephone and Telegraph
Company; GTC, Inc. will grant permission to St. Joseph Telephone & Telegraph Company to
assume the name GTC, Inc., and GTC, Inc. will be dissolved; and St. Joseph Telephone &

Florala's Certificate is FPSC Certificate No. 4, issued December 9, 1954, Gulf's Certificate is FPSC Certificate No. 21, issued September 8, 1955, as amended by FPSC Order No. 3735, January 6, 1965, and FPSC Order No. 6502, February 6, 1975; St. Joseph Telephone & Telegraph Company's Certificate is FPSC Certificate No. 29, issued February 2, 1956, as amended by FPSC Order No. 2405, November 6, 1956, FPSC Order No. 3550, March 20, 1963, and FPSC Order No. 18308, August 24, 1987.

Operating Companies served the following number of Florida subscribers (access lines): Florala - 2,290; Gulf - 9,222; and St. Joseph - 30,508. After the consolidation, all approximately 42,000 Florida subscribers will be served by St. Joseph Telephone & Telegraph Company renamed as GTC, Inc. As of June 24, 1997, there were 3, 31 and 71 applications for service pending with Florala, Gulf and St. Joseph, respectively. No change in the calling scope is proposed. All existing customers of Gulf Telephone Company and The Florala Telephone Company, Inc. will be transferred. No customers are exempt. Attached as Attachment A is a list of the services being provided by The Florala Telephone Company, Inc. and Gulf Telephone Company, all of which will be transferred to St. Joseph Telephone & Telegraph Company renamed as GTC, Inc.

6. St. Joseph Telephone & Telegraph Company does not propose as part of this consolidation any change to the rates or the scope of service offered by the Operating Companies. Each of the Operating Companies have opted for price cap regulation, so the currently filed and approved rates for the Operating Companies will serve, under existing statutes, as a price ceiling. Consistent with Florida Administrative Code Rule 25-9.044, within ten (10) days of the consolidation of the Operating Companies, St. Joseph Telephone & Telegraph Company, renamed as GTC, Inc., will issue and file a notice adopting all rates, rules and classifications of the Operating Companies. Within thirty (30) days of the filing of such adoption notice, GTC, Inc. shall issue and file in its name a complete reissuance of its Tariff incorporating the rates of the Operating Companies.

² Upon consultation with the Staff, the Operating Companies are prepared to perform this Tariff reissuance by forwarding to the Staff stickers for each page of each of the Operating Companies' existing Tariffs to reflect the new company name of GTC, Inc. GTC, Inc. initially will operate under three separate tariffs to facilitate the application of Rule 25-9.044, Florida Administrative Code.

- 7. All deposits and deposit interest held by Gulf Telephone Company and The Florala Telephone Company, Inc. will be transferred to St. Joseph Telephone & Telegraph Company. As of May 31, 1997, the Operating Companies held deposits and deposit interest as shown on Attachment B.
- As this is an internal corporate restructuring, there is no consideration or financial exchange for the proposed changes.
- 9. Attached as Attachment C is an affidavit of Mr. James B. Faison, Vice President/ Controller of the Operating Companies. In the affidavit Mr. Faison states that all the required notices of the intent to petition for the transfer of certificates were duly provided. He also attests to the truth of the factual representations in this petition. In lieu of attaching to this petition a complete list of all subscribers sent a written notice of this petition, on June 6, 1997, the Operating Companies petitioned the Commission for a partial waiver of Rule 25-4.005, Florida Administrative Code.
 - 10. The joint petitioners are not aware of any material issues of disputed fact.
- 11. The joint petitioners respectfully submit that the proposed consolidation and transfer of certificates is in the public interest. The consolidation and transfer of certificates will allow corporate and operational streamlining of common functions currently performed by each of the operating companies. It will reduce regulatory filing requirements. It will allow better coordination of assets, resources and personnel already under control of a common parent.

 Customers should benefit from enhanced service delivery and improved efficiencies from consolidation. Customers will not face a rate increase as a result of the consolidation, and they will enjoy the same scope of service and calling areas as they currently enjoy.

12. The joint petitioners respectfully request that this Petition be handled through the Commission's Proposed Agency Action process as set forth in Florida Administrative Code Rule 25-22.029 and that the Petition be placed for decision on the Commission's Agenda Conference schedule as soon as practicable.

WHEREFORE, for the reasons set forth above, the joint petitioners respectfully request that the Commission approve, through its Proposed Agency Action procedures, the consolidation of The Florala Telephone Company, Inc. and Gulf Telephone Company into St. Joseph Telephone & Telegraph Company, the associated transfer of the certificates of public convenience and necessity of The Florala Telephone Company, Inc. and Gulf Telephone Company to St. Joseph Telephone & Telegraph Company, and the change of the name of the St. Joseph Telephone & Telegraph Company to GTC, Inc.


