After reviewing the application in the above referenced docket, the staff has identified the following deficiencies. Please correct and/or provide additional information as requested.

1. As required by Rule 25-30.036(3)(b), Florida Administrative Code, the utility must provide a statement showing the financial and technical ability of the utility to provide service and the need for service in the area requested. Although a statement was provided on the financial ability and the need for service, please provide more information on the technical ability of the utility such as your certified operators and engineering firm or engineer the utility retains.

2. As required by Section 367.045(1)(a), Florida Statutes, and Rule 25-30.030, Florida Administrative Code, the utility must provide notice to the governmental entities and the private utilities. Copies of the Notice and a list of entities noticed shall accompany the affidavit. Although an affidavit was filed, the list did not identify the addresses of the utilities and governmental ACK _ agencies. Please resubmit the affidavit and attach a copy of the list we sent the utility. We have AFA ____ -enclosed a copy of the entities in DeSoto and Charlotte Counties that are required to receive notice. APP -3. As required by Rule 25-30.036(3)(c), Florida Administrative Code, provide a statement CAF _ that to the best of the applicant's knowledge the provision of service will be consistent with the CMU _ -water and wastewater sections of the local comprehensive plan at the time the application is filed, CTR _____as approved by the Department of Community Affairs, or, if not, a statement demonstrating why granting the amendment would be in the public interest. Although a statement was provided the EAG statement is not clear. Please revise and refile the statement.

6. As Required by Rule 25-30.036(3)(o), provide the original and two copies of sample tariffs reflecting the additional service area. There was one error in the tariff. We have attached the sheet, so it can be corrected. Please review and refile.

The copies in Exhibit B.1 and B.2 do not have the bottom half of the pages. Please resubmit.
