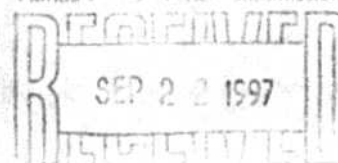

MR. KEATING:

AN OFFICIAL PROTEST HAS BEEN FILED ON THE LATEST RECOMMENDATION AND PROPOSED AGENCY ACTION REGARDING THIS MATTER.

ADDITIONALLY COMPLAINTS OF RACIAL DISCRIMINATION ON THE PART OF STAFF MEMBERS DURBIN, PLESCOW, DILLMORE, MAKIN (ESPECIALLY THIS MEMBER) AND YOURSELF ARE GOING TO BE FILED. IT WAS APPARENT FROM THE OFFSET THAT PLESCOW WANTED US TO DROP THE COMPLAINT AGAINST THE GAS COMPANY AND BEFORE GATHERING ALL THE DATA WAS TRYING TO DISUADE US FROM PROCEEDING.

WHEN HIS FIRST SET OF RECOMMENDATIONS WAS MET WITH STERN OPPOSITION; YOUR ATTITUDE TOWARDS US WAS MORE THAN JUST UN-FRIENDLY AND LACKING RESPECT.

IT BECAME CLEAR THAT THIS LAST HEARING WAS GOING TO BE NOTHING MORE THAN AN ATTEMPT TO JUSTIFY YOUR FIRST SET OF RECOMMENDATION WHEN YOU FAILED TO DEMAND THE GAS COMPANY PRODUCE DOCUMENTS TO SHOW WHY THEY WERE MISSING RECORDING OF PAYMENTS AND ACTUAL DOCUMENTS TO SHOW RECEIPT OF PAYMENT AND EXACTLY WHERE THE PAYMENTS WENT. INSTEAD WE SAT THERE AND WATCHED YOU PEOPLE TRY AND JUSTIFY THE COMPANY'S ERRORS AND MAKE EXCUSES FOR THEM.

YOU THEN EVEN AFTER THE COMPANY HAD TO ADMIT WRONGDOINGS IN THE FACE OF EVIDENCE WE SUPPLIED; YOU DISTORTED THE TRUTH, LIED AND HID EVENTS IN YOUR RENDERINGS BEFORE THE COMMISSION.

WE ALSO FOUND IT VERY INTERESTING THAT THE ONLY BLACK MEMBER OF STAFF WHO PARTICIPATED IN THE ORIGINAL HEARING WAS TAKEN OUT OF THE LOOP IN YOUR LATEST ATTEMPTS TO JUSTIFY FPU ACTS.

ADDITIONALLY; COMPLAINTS WILL ALSO BE MADE AND PURSUED AGAINST STAFF FOR KNOWINGLY ENTERING FALSE, MISLEADING AND FORGED MATERIALS INTO PUBLIC RECORDS.

JUST AS IT WAS EASY TO SHOW ERRORS IN TROY'S ACCOUNT OF EVENTS; IT WILL BE JUST AS EASY TO DEMONSTRATE THE VALIDITY OF THE COMPLAINTS.

YOUR OFFICE CHOSE TO OVER LOOK DOCUMENTATION AND TAKE THE WORD OF A LIAR AND A PERSON WHO SAT BEFORE YOU WITH NO EVIDENCE; JUST WORD OF MOUTH AND RUN WITH IT AND DISTORT FACTUAL DATA AND TRY AND BRAND AN INJURED PARTY AS LIARS IN SUPPORT OF HIM.  
WE DO NOT LIE, DID NOT LIE AND PRESENTED EVIDENCE OF WRONG DOING.

SOMETHING YOU CHOSE TO IGNORE OR MAKE LIGHT OF.

IF YOU REPRESENT THE GAS COMPANY; THEN YOU SHOULD TELL THE CITIZENS OF THAT FACT.

YOUR ACTIONS GIVE RISE TO THE BOILER ROOM POLITICS OF ALL AND MAKE US WONDER JUST HOW MUCH YOU ALL WERE PAID BY TROY.

WE CAME TO YOU SEEKING JUSTICE AND GOT AN OLD DOSE OF DISCRIMINATORY ACTIONS MORE IN TUNE WITH THE 60'S AND 70'S.

YOU MADE ONLY ONE MISTAKE:

YOU ASSUME THAT WE ARE BLACK PEOPLE FROM THAT ERA BUT WE ASSURE YOU WE ARE VERY MUCH OF THE NINeties AND WILL NOT BE DETERRED BY A FEW RACIST ACTIONS.

WE ARE PREPARED TO GO THE LIMIT; EVEN TO THE U.S. SUPREME COURT OVER THIS MATTER.

AS FOR TROY; HE HAS BEEN TAKEN OUT OF THE HANDS OF BUREAUCRATS AND PUT IN THE HANDS OF THE CIRCUIT COURT.
