13	arising under resale agreement with BellSouth
14	Telecommunications, Inc.
15	COMMISSIONER GARCIA: Okay. We'll take
16	appearances.
17	MS. WHITE: Nancy White and Greg Artis on
18	behalf of BellSouth.
19	COMMISSIONER GARCIA: I'm sorry, Nancy White

21	MS. WHITE: Greg Artis, a-R-T-I-S.
22	MR. BOYD: Everett Boyd on behalf of
23	National Telecommunications.
24	COMMISSIONER GARCIA: Okay.
25	MR. COX: Will Cox on behalf of the

21	us, too.
22	COMMISSIONER GARCIA: Okay.

25	want us to go through the order or is there something

1	you would like to address and that way we can skip
2	through that ordeal.
3	MS. WEITE: We've looked through the
4	prehearing statement, and it appears correct to us
5	from BellSouth's view.
6	MR. BOYD: And it looks correct to us, too,
7	Commissioner. I don't see a need to go through it
8	step-by-step.
9	COMMISSIONER GARCIA: Okay.
10	MR. BOYD: There's one additional matter I'd
11	like to raise. I'd like to request that we be
12	permitted to make brief opening statements at the
13	hearing. I don't believe this is going to be a
14	lengthy hearing.
15	COMMISSIONER GARCIA: Right.
16	MR. BOYD: So, I think
17	COMMISSIONER GARCIA: Why lengthen it?
18	MR. BOYD: Well, I think that this is more
19	an interpretation legal interpretation and
20	application of the contract.

23	MR. BOYD: Yes, sir, that would be mine.
