Issue 1: Should the Commission require GTE Florida Incorporated to respond to the audit requests issued by the Division of Auditing and Financial Analysis on January 16, 1998, pursuant to Section 364.183, Florida Statutes?

Recommendation: Yes. The Commission should require GTE Florida Incorporated to comply with the audit request regarding components of the cost study data filed in response to Order No. PSC-97-0064-FOF-TP, issued January 17, 1997. The records that are the subject of this audit request are reasonably necessary for the disposition of matters properly before the Commission in this proceeding. Staff recommends that the Commission issue an order permitting the requested audit to go forward immediately so that
