January 6, 1997

I am writing to you in response to the enclosed Regulatory Assessment Fee Return form. As I have indicated on the form, the pay phones which I operated for approximately two months returned a total of less than \$60.00 total revenues. During this time I paid \$838.80 to GTE Florida for misc. services, installation fees, etc. I do not have a listing for this as I paid through a company which had promised to set me up in the "payphone business". This was a new business for me that soon turned into somewhat of a financial disaster, and I quickly had the lines disconnected and sold the equipment to try to recover some of my lost investment. The company that was supposedly handling everything for me was Comtel Communications located at 3467 NE 163rd St. - North Miami Beach Fla.

I have since learned that on November 6, 1996 the Federal Trade Commission filed a civil action against Comtel for various reasons including using their certificate to allow others to provide payphone services prior to obtaining their own certification. I do not know the current status of Comtel or the civil action, because as I stated above, I sold the equipment as soon as I could in an attempt to recover some of my lost money and in order to wash my hands of Comtel, as they promised a lot, but delivered very little. I again they a novice at this sort of business, and wish every day that I had never heard of Comfel. My phone locations were total losers and I had to shut down because I couldn't afford to base any more money.

I would provide you more information if I had it, but I am flairly ignorant as to the real workings of this business. I am just glad to be done with it. Please let me know if your require anything else. I would also like to cancel my Certificate with this letter, although I don't think I ever really received one. Can you confirm to me if this letter is sufficient for cancellation, so I won't have to pay this fee again?
