Dear Ms. Bayo:

On behalf of WorldCom, Inc. ("WorldCom"), MFS Intelenet of Florida ("MFS of Florida") and WorldCom Technologies, Inc. ("WorldCom Technologies"), I am writing to advise you that the corporate structure resulting from the reorganization approved by the Florida Public Service Commission ("Commission") in the above-referenced docket has been finalized. As you are aware, on September 29, 1997, the Commission issued an order authorizing WorldCom and MFS of Florida to consolidate their operations into WorldCom Technologies. A copy of the final organizational chart for Florida is appended hereto for your information.

As you can see from this organizational chart, MFS Network Technologies, Inc. remains in the corporate chain of ownership of WorldCom Technologies. *Therefore, there has been, and will be, no change in the ownership of WorldCom Technologies resulting from the reorganization.* The request for an IRS private letter ruling which would have precipitated the removal of MFS Network Technologies, Inc. from the chain of ownership of WorldCom Technologies will be withdrawn as a result of a change in the WorldCom companies' business plans.
