Notification of Internal Corporate Reorganization and Name Change of UniDial

Incorporated

Dear Ms. Bayo:

On behalf of UniDial Incorporated ("UniDial" or "Company"), this letter is to notify the Commission of the Company's intention to undertake an internal corporate reorganization (the "Reorganization") whereby UniDial will change its name to UniDial Communications, Inc. ("UniDial Communications"), and UniDial Communications will, through a series of transactions, become a wholly-owned subsidiary to a newly created parent Company, UniDial Holdings, Inc. ("UniDial Holdings"). As discussed in further detail below, following the Reorganization UniDial Holdings, which will hold 100% of the stock of UniDial Communications, shall be owned by the present owners of UniDial in proportions identical to their current interest in UniDial. Consequently, this series of transactions constitutes a pro forma reorganization. In essentially all respects, the Reorganization will be virtually transparent to the Company's customers.

Upon review of the Florida statutes and Commission rules, it is the understanding of the Company that prior Commission approval is not required for the proposed transaction. Therefore, absent receipt of written notification to the contrary within thirty (30) days, the Company will proceed on the understanding that no approval or other formal action with respect to the Reorganization is required by the Commission.

#### THE REORGANIZATION

UniDial is a Kentucky corporation, qualified to do business in the State of Florida, whose principal offices are located at One Corporate Center, 9931 Corporate Campus Drive, Louisville, Kentucky 40223. UniDial, by Order dated December 2, 1993, in Docket No. 930865-Tl (Order No. PSC-93-1651-FOF-Tl), is authorized to provide intrastate long distance services in the State of

Florida. UniDial is also authorized to provide resold intrastate long distance telecommunications services in every state except Alaska and Hawaii, pursuant to certification, registration, or (where appropriate) deregulation. In addition, UniDial offers a wide range of integrated and competitively priced domestic and international long distance telephone services in the U.S. and abroad, through its network of switches and leased lines interconnected to other domestic and foreign carriers. UniDial is also authorized by the Federal Communications Commission ("FCC") to provide international switched and private line telecommunications services between the United States and various international points.<sup>1</sup>

Information concerning the legal, technical, managerial and financial qualifications of UniDial to provide service was submitted with its application for certification filed with the Commission in the docket noted above. It is not anticipated that there will be any change in corporate officers, directors, or change in the pricing of services offered to customers as a result of the Reorganization. UniDial, therefore, respectfully requests that the Commission take official notice of that information and incorporate it by reference herein.

For internal corporate reasons, UniDial has determined that the operational efficiency and competitive position of the Company will be enhanced by the Reorganization. The Reorganization will enable the Company to attract additional financing, reducits operating expenses and realize operational and management efficiencies and other corporate benefits that ultimately will accrue to the benefit of UniDial customers.

The first step of the Reorganization will consist of the name change from UniDial Incorporated to UniDial Communications, Inc.<sup>2</sup> Subsequent to the name change, UniDial Communications will become a wholly-owned subsidiary of UniDial Holdings, Inc., a newly created company incorporated in Delaware on March 3, 1998. UniDial Communications was qualified to do business in Florida with the Secretary of State's Office on March 18, 1998. A copy of the applicable qualification and other corporate papers are attached hereto as Exhibit A. Accordingly, following the Reorganization UniDial Communications will be 100% owned by its corporate parent, UniDial Holdings, which will, in turn, be owned by the present owners of UniDial, in proportions

Pursuant to discussions with Tom Williams of the Commission's staff, and in order for UniDial's tariff currently on file with the Commission to reflect the name change of UniDial Incorporated to UniDial Communications, Inc., attached hereto are labels, containing UniDial Communication's name, to be placed on UniDial's existing tariff. Through the placement of the labels on UniDial's tariff, UniDial Communications effectively adopts UniDial's tariff, including all service offerings, rates, terms and conditions contained within that tariff. UniDial will notify customers of the name change by billing insert or notification when it finalizes the Reorganization.

identical to their current interest in UniDial. The new corporate structure of UniDial, as well as the corporate structure prior to the Reorganization, is illustrated in the chart attached hereto as Exhibit B.

The name change from UniDial to UniDial Communications and the creation of UniDial Holdings as UniDial Communications' parent company will be made in a seamless fashion that will not adversely affect the offering of telecommunications services in Florida but will increase the financial and managerial strength of the entity which is providing service in Florida. The Reorganization will simply be a paper transaction that will be transparent to consumers and will not in any way inconvenience or cause harm to UniDial's customers.

As stated above, it is not anticipated that the Reorganization will result in any change in the officers and directors of the certified entity. There is also no intention, as a result of the Reorganization, to change management, operations, or the services provided to Florida customers. Consumers will continue to be provided high quality, affordable services by UniDial Communications. Therefore, the Reorganization will be entirely transparent to customers.

UniDial provides residential and small business customers high quality, cost effective telecommunications services, with an emphasis on customer service. UniDial has determined that the Reorganization would enhance operational efficiency and competitive position, providing UniDial with greater flexibility to obtain financing for its continuing expansion, and secure its competitive position in the telecommunications marketplace. Consequently, the Reorganization is consistent with the public interest in promoting competition among telecommunications carriers in Florida.
