 ("Supra") hereby requests the Prehearing Officer to permit it to

 Due to the compact time frame for this proceeding and the fact  
 that Supra has been involved in two other proceedings  
 simultaneously, Supra did not have adequate time prior to filing  
 its direct testimony on March 25, 1998, to include everything  
 that it needed to include in its direct testimony. Supra has  
 filed Olukayode A. Ramos' amended testimony with four additional  
 exhibits. All of the previously-filed exhibits attached to Mr.  
 Ramos' initial testimony should be retained, but the initial  
 testimony should be completely discarded. Supra has filed one


