**NOTICE OF WITHDRAWAL OF REQUEST FOR CANCELLATION**

ICG Telecom Group, Inc. through its undersigned counsel, hereby gives notice of the withdrawal of its request for cancellation of IXC Certificate No. 3986, and states:

1. ICG Telecom Group, Inc. ("ICG Telecom") holds IXC Certificate No. 3986, pursuant to Order No. PSC-95-0458-FOF-TI, issued April 7, 1995.
2. On January 16, 1998, an individual in ICG Telecom's tax section indicated in a letter to the Commission that ICG Telecom would be filing no regulatory assessment fees pursuant to the certificate in the future. The individual was in error, and in fact had no authority to make the statement.
3. However, the erroneous communication was treated by the Commission Staff as a request to cancel the certificate, and was placed on the Consent Agenda of March 10, 1998.
4. Subsequently, the Commission issued PAA Order No. PSC-98-0415-FOF-TI, in which it proposed to cancel Certificate No. 3986.<sup>1</sup>

<sup>1</sup> In Order No. PSC-98-0415-FOF-TI, the Commission consolidated the ICG Telecom item with two other dockets in which carriers requested the Commission to cancel their certificates. ICG Telecom's Notice of Withdrawal affects the order only as it relates to Certificate No. 3986.
