Dear Mrs. Brady:

I will again attempt to update your administration on the status of our hookup to the Manatee County Sewer System. First let me say we have now completed one year hooked up to the county water system. The process for the sewer is proceeding along at a slow but steady pace. We are continuing to work with the same engineer, Mr. Ron Larson and he has met with the county officials that we are working with. We have secured all the nesessary permits which was a major accomplishment. All the engineering work has been completed and bids have been received for the work.

The next step for us is to continue to raise the funds to complete this project. We are proceeding just as we did for the water hook up. We have requested the contractor Westra, Inc. to schedule the work to begin within the next few months and to complete the work before the year end.

We feel confident that we will complete the process in a timely manner meeting the deadlines the county will set. We are committed to hooking up to the county sewer system by beginning the construction as soon possible.

 - 1. Substantial modifications have been eliminated from this application.
 - 2. The intent is to continue land spreading with sludge treatment at the WWTP site. The hauling contract offers treatment on an emergency basis only.
 - 3. It is not the intent to transport sludge to another facility for treatment.
 - 4. Comment noted.
 - 5. Effluent application rate has been added.
 - 6. Schedule pertains to taking the facility off-line and has been noted as such.
 - 7. Process flow diagram and site plan are enclosed as requested.
 - 8. Signatory has been changed to corporate president. Records are available at the administrative office.
- C. The plant flow diagram has been added to copies of the O & M Performance Report. Information requested is provided on the diagram.
- D. General
 - 1. Sketches are enclosed as requested.
 - Gospel Crusade has a trailer-mounted emergency generator on site with capacity to operate the lift station and WWTP in an emergency.
