MOTION OF AMERITECH COMMUNICATIONS INTERNATIONAL, INC. FOR PROTECTIVE ORDER REQUESTING CONFIDENTIAL CLASSIFICATION FOR RESPONSE TO COMMISSION DATA REQUESTS

Ameritech Communications International, Inc. ("ACII"), through its counsel, and pursuant to Chapter 364.183 of the Florida Statutes and Chapter 25-22.06 of the Florida Rules of Practice and Procedures, hereby respectfully moves the Florida Public Service Commission ("Commission") for a protective order classifying ACII's response to the Commission's Data Requests, Questions 1-4, in Docket No. 960786-TL (the "Data Requests") as confidential information. This response contains information which ACII considers proprietary confidential business information constituting trade secrets and relating to ACII's competitive interests, the disclosure of which would impair ACCI's ability to compete in Florida.

ACII believes that disclosure of this information would require it to reveal highly valuable, commercial information which ACII considers confidential, proprietary and a trade secret. Specifically, the above-referenced response contains proprietary business information concerning ACII's operations and customers. Disclosure of this information would allow a competitor to make determinations that are relevant to competitive services, and provide such competitor an advantage in the local service marketplace. The growth in competitive alternatives increases the need to protect this information by placing it under protective seal.

Moreover, disclosure of such information would severely jeopardize ACII's ability to compete with other telecommunications providers. ACII has and will continue to use its best efforts to treat the information in the above-referenced document privately and not disclose it. If this information were to be published or released to the public, competitors would find it of great economic value in determining their own business plans, and in many cases could use such information to structure their plans in such a way to undercut ACII's competitive position.

Attached hereto as Exhibit 1 is a copy of ACII's Responses to the Data Requests, enclosed in a sealed enveloped.

For the above reasons, ACII respectfully moves that the Commission grant a Protective Order classifying ACII's response as confidential information and allowing ACII to file the response under seal.
