ORDER APPROVING RESALE AGREEMENT'

BY THE COMMISSION:

On February 6, 1998, BellSouth Telecommunications, Inc. (BST) and Utilicore Corporation (Utilicore) filed a request for approval of a resale agreement inder the Telecommunications Act of 1996, 47 U.S.C. §252(e) of the Telecommunications Act of 1996 (the Act). The agreement is attached to this Order as Attachment A and incorporated by reference herein.

Both the Act and Chapter 364, Florida Statutes, encourage parties to enter into negotiated agreements to bring about local exchange competition as quickly as possible. Under the requirements of 47 U.S.C. § 252(e), negotiated agreements must be submitted to the state commission for approval. Section 252(e)(4) requires the state to reject or approve the agreement within 90 days after submission or it shall be deemed approved.

This agreement covers a two-year period and governs the relationship between the companies regarding the resale of tariffed telecommunication services. Under 47 U.S.C. § 252(a)(1), the agreement shall include a detailed schedule of itemized charges for interconnection and each service or network element included in the agreement. provided by BST for resale will be available for purchase by Utilicore at a discount rate of 21.83% for residential services and 16.81% for business services.

Upon review of the proposed agreement, we find that it complies with the Telecommunications Act of 1996; thus, we hereby approve it. BST and Utilicore must file any supplements or modifications to their agreement with the Commission for review under the provisions of 47 U.S.C. § 252(e).

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the resale agreement between BellSouth Telecommunications, Inc. and Utilicore Corporation, as set forth in Attachment A and incorporated by reference in this Order, is hereby approved. It is further

ORDERED that any supplements or modifications to this agreement must be filed with the Commission for review under the provisions of 47 U.S.C. § 252(e). It is further

ORDERED that this docket shall be closed.

ATTACHMENT A

Agreement Between BellSouth Telecommunications, Inc. and Utilicore Corporation Regarding The Sale of BellSouth Telecommunications Services to Utilicore Corporation For The Purposes of Resale

THIS AGREEMENT is by and between BellSouth Telecommunications, Inc., ("BellSouth or Company"), a Georgia corporation, and Utilicore Corporation ("Utilicore Corporation"), a Florida corporation, and shall be deemed effective as of January 15, 1998.

WITNESSETH

WHEREAS, BellSouth is a local exchange telecommunications company authorized to provide telecommunications services in the states of Alebama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, and Tennessee: and

WHEREAS, Utilicere Corporation is or seeks to become an alternative local exchange telecommunications company authorized to provide telecommunications services in the states of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, and Tempessee; and

WHEREAS, Utilicore Corporation desires to resell BellSouth's telecommunications services; and

WHEREAS, BeliSouth has agreed to provide such services to Utilicore Corporation for resale purposes and pursuant to the terms and conditions set forth hereig:

NOW, THEREFORE, for end is consideration of the mutual premises and promises contained herein, BeilSouth and Utilicore Corporation do hereby agree as follows:

1. Term of the Agreement

- A. The term of this Agreement shall be two years beginning January 15, 1998 and shall apply to all of BellSouth's serving territory as of January 1, 1998 in the states of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, and Tennesses;
- B. This Agreement shall be automatically renewed for two additional one year periods unless either party indicates its intent not to renew the Agreement. Notice of such intent must be provided, in writing, to the other party no later than 60 days prior to the end of the then-existing contract period. The terms of this Agreement shall remain in effect after the term of the existing agreement has expired and while a new agreement is being negotiated.

The rates pursuant by which Utilicore Corporation is to purchase services from BellSouth for resale shall be at a discount rate off of the retail rate for the telecommunications service. The discount rates shall be as set forth in Exhibit A, attached hereto and incorporated herein by this reference. Such discount shall reflect the costs avoided by BellSouth when selling a service for wholesale purposes.

II. Definition of Terms

A. CUSTOMER OF RECORD means the entity responsible for placing application for service; requesting additions, rearrangements, maintenance or discontinuance of service; psyment in full of charges incurred such as non-recurring, monthly recurring, toll, directory assistance, etc.

- DEPOSIT means assurance provided by a customer in the form of cash, surety bond or bank letter of credit to be held by the Company.
- C. END USER means the ultimate user of the telecommunications services.
- D. END USER CUSTOMER LOCATION means the physical location of the premises where an end user makes use of the telecommunications pervious.
- E. NEW SERVICES means functions, fluctures or capabilities that are not currently offered by BellSouth. This includes packaging of existing services or combining a new function, feature or capability with an existing service.
- F. OTHER LOCAL EXCHANGE COMPANY (OLEC) means a telephone company certificated by the public service commissions of the Company's franchised area to provide local exchange service within the Company's franchised area.
- G. RESALE means an activity wherein a certificated OLEC, such as Utilicore Corporation subscribes to the telecommunications services of the Company and then reoffers those telecommunications services to the public (with or without "adding value").
- H. RESALE SERVICE AREA means the area, as defined in a public service commission approved certificate of operation, within which an OLEC, such as Utilicare Corporation, may offer resold local exchange telecommunications service.

III. General Provisions

A. Utilicore Corporation may resell the tariffed local exchange and toll telecommunications services of BellSouth contained in the General Subscriber Service Tariff and Private Line Service Tariff subject to the terms, and conditions specifically set forth herein. Notwithstanding the foregoing, the exclusions and limitations on services available for resale will be as set forth in Exhibit B, attached hereto and incorporated herein by this reference.

BellSouth shall make available telecommunications services for resale at the rates set forth in Exhibit A to this agreement and subject to the exclusions and limitations set forth in Exhibit B to this agreement. It does not however waive its rights to appeal or otherwise challenge any decision regarding resale that resulted in the discount rates contained in Exhibit A or the exclusions and limitations contained in Exhibit B. BellSouth reserves the right to pursue any and all legal and/or equitable remedies, including appeals of any decisions. If such appeals or challenges result in changes in the discount rates or exclusions and limitations, the parties agree that appropriate modifications to this Agreement will be made promptly to make its terms consistent with the outcome of the appeal.

- B. Utilicore Corporation may purchase resals services from BellSouth for their own use in operating their business. The resale discount will apply to those services under the following conditions:
 - 1. Utilicore Corporation must result services to other and users.
 - Utilicore Corporation must order services through resale interfaces, i. e., the LCSC and/or appropriate Resale Account Teams.
 - Utilicore Corporation cannot be an alternative local exchange telecommunications company for the single purpose of selling to themselves.

- C. The provision of services by the Company to Utilicore Corporation does not constitute a joint undertaking for the furnishing of any service.
- D. Utilicore Corporation will be the customer of record for all services purchased from BellSouth. Except as specified herein, the Company will take orders from bill and expect payment from Utilicore Corporation for all services.
- E. Utilicore Corporation will be the Company's single point of contact for all services purchased pursuant to this Agreement. The Company shall have no contact with the and user except to the extent provided for harnin.
- F. The Company will continue to bill the end user for any services that the end user specifies it wishes to receive directly from the Company.
- G. The Company meintains the right to serve directly any and user within the service area of Utilicore Corporation. The Company will continue to directly market its own telecommunications products and services and in doing so may establish independent relationships with end users of Utilicore Corporation.
- H. Neither Party shall interfere with the right of any person or entity to obtain service directly from the other Party.
- I. Current telephone numbers may normally be retained by the end user. However, telephone numbers are the property of the Company and are assigned to the service furnished. Utilicore Corporation has an property right to the telephone number or any other cell number designation associated with services furnished by the Company, and no right to the Lontinuance of service through any particular central office. The Company reserves the right to change such numbers, or the central office designation associated with such numbers, or both, whenever the Company deems it necessary to do so in the conduct of its business.
- J. The Company may provide any service or facility for which a charge is not established herein, as long as it is offered on the same terms to Utilicore Corporation.
- K. Service is furnished subject to the condition that it will not be used for any unlawful purpose.
- Service will be discontinued if any law enforcement agency advises that the service being used is in violation of the law.
- M. The Company can refuse service when it has grounds to believe that service will be used in violation of the law.
- N. The Company accepts no responsibility to any person for any unlawful act committed by Utilicore Corporation or its end users as part of providing service to Utilicore Corporation for purposes of resale or otherwise.
- O. The Company will cooperate fully with law enforcement agencies with subposens and court orders for assistance with the Company's customers. Law enforcement agency subposens and court orders regarding end users of Utilicore Corporation will be directed to Utilicore Corporation. The Company will bill Utilicore Corporation for implementing any requests by law enforcement agencies regarding Utilicore Corporation and users.
- P. The characteristics end methods of operation of any circuits, facilities or equipment provided by any person or entity other than the Company shall not:

- Interfere with or impair service over any facilities of the Company, its affiliates, or its connecting and concurring carriers involved in its service;
 - Cause damage to their plant;
- 2. Impair the privacy of any communications; or
- 3. Create hazards to any employees or the public.
- Q. Utilicore Corporation assumes the responsibility of notifying the Company regarding less than standard operations with respect to services provided by Utilicore Corporation.
- R. Facilities and/or equipment utilized by BellSouth to provide service to Utilicore Corporation remain the property of BellSouth.
- White page directory listings will be provided in accordance with regulations set forth in Section A6 of the General Subscriber Service Terriff and will be available for resale.
- T. BellSouth will provide customer record information to Utilicore Corporation provided Utilicore Corporation has the appropriate Letter(s) of Authorization. BellSouth may provide customer record information via one of the following methods: US mail, fax, or by electronic interface. BellSouth will provide customer record information via US mail or fax on an interim basis only.
 - Utilicore Corporation agrees to compensate BellSouth for all BellSouth incurred expenditures
 associated with previding such information to Utilicore Corporation. Utilicore Corporation will
 adopt and adhere to the BellSouth guidelines associated with each method of providing customer
 record information.
 - All costs incurred by BellSouth to develor and implement operational interfaces shall be recovered from Utilicore Corporation who utilize the services.
- U. BellSouth will provide certain selected messaging services to Utilicore Corporation for resale of messaging service without the wholesale discount.
- V. BellSouth's Inside Wire Maintenance Plans may be made available for resale at rates, terms and conditions as set forth by BellSouth and without the wholesale discount.
- W. All costs incurred by BellSouth for providing services to Utilicore Corporation that are not covered in the BellSouth tariffs shall be recovered from Utilicore Corporation.
- IV. BellSouth's Provision of Services to Utilicore Corporation
 - A. Utilicore Corporation agrees that its resals of BellSouth services shall be as follows:
 - The resule of telecommunications services shall be limited to users and uses conforming to the class of service restrictions.
 - 2. To the extent Utilicore Corporation is a telecommunications carrier that serves greater than 5 percent of the Nation's presubscribed access lines, Utilicore Corporation shall not jointly market its interLATA services with the telecommunications services purchased from BellSouth purment to this Agreement in any of the states covered under this Agreement. For the purposes of this subsection, to jointly market means any advertisement, marketing effort or billing in which the telecommunications services purchased from BellSouth for purposes of resals to customers and interLATA services offered by Utilicore Corporation are packaged, tied, bundled, discounted or

offered together in any way to the end user. Such efforts include, but are not limited to, sales referrals, resale arrangements, sales agencies or billing agreements. This subsection shall be void and of no effect for a particular state covered under this Agreement as of February 8, 1999 or on the date BellSouth is authorized to offer interLATA services in that state, whichever is earlier.

- 3. Hotel and Hospital PBX service are the only telecommunications services available for resale to Hotel/Motel and Hospital and upors, respectively. Similarly, Access Line Service for Customer Provided Coin Telephones is the only local service available for resale to Independent Psyphone Provider (IPP) customers. Shared Tenant Service customers can only be sold those telecommunications services available in the Company's A23 Shared Tenant Service Tariff.
- 4. Utilicore Corporation is prohibited from furnishing both flat and measured rate service on the same business premises to the same subscribers (and users) as stated in A2 of the Company's Tariff except for backup service as indicated in the applicable state turiff Section A3.
- 5. If telephone service is established and it is subsequently determined that the class of service restriction has been violated, Utilicare Corporation will be notified and billing for that service will be immediately changed to the appropriate class of service. Service charges for changes between class of service, back billing, and interest as described in this subsection shall apply at the Company's sole discretion. Interest at a rate as set forth in Section A2 of the General Subscriber Service Tartiff and Section B2 of the Private Line Service Tartiff for the applicable state, compounded delity for the mumber of days from the back billing date to and including the date that Utilicare Corporation actually makes the payment to the Corporaty may be assessed.
- 6. The Company reserves the right to periodically sudit services purchased by Utilicore Corporation to establish authenticity of use. Such audit shall not occur more than once in a calendar year. Utilicore Corporation shall make any and all records and data available to the Company or the Company's suditors on a reasonable basis. The Company shall bear the cost of said audit.
- B. Resold services can only be used in the same manner as specified in the Company's Tariff. Resold services are subject to the same terms and conditions as are specified for such services when furnished to an individual and user of the Company in the appropriate section of the Company's Tariffs. Specific teriff features, e.g. a mage allowance per month, shall not be aggregated across multiple resold services. Resold services cannot be used to aggregate traffic from more than one end user customer except as specified in Section A23. of the Company's Tariff referring to Shared Tenant Service.
- C. Utilicore Corporation may resell services only within the specific resale service area as defined in its certificate.
- D. Telephone numbers transmitted via any resold service feature are intended solely for the use of the enduser of the feature. Resale of this information is proh!blad.
- E. No patent, copyright, trademark or other proprietary right is licensed, granted or otherwise transferred by this Agreement. Utilicore Corporation is strictly prohibited from any use, including but not limited to sales, marketing or advertising, of any BellSouth name or trademark.

V. Maintenance of Services

- A. Utilicore Corporation will adopt and adhere to the standards contained in the applicable BellSouth Work. Center Interface Agreement regarding maintenance and installation of service.
- B. Services resold under the Company's Turiffs and facilities and equipment provided by the Company shall be maintained by the Company.

- C. Utilicore Corporation or its end users may not rearrange, move, disconnect, remove or attempt to repair any facilities owned by the Company, other than by connection or disconnection to any interface means used, except with the written consent of the Company.
- D. Utilicore Corporation accepts responsibility to notify the Company of situations that grise that may result in a service problem.
- E. Utilicore Corporation will be the Company's single point of contact for all repair calls on behalf of Utilicore Corporation's and users. The parties agree to provide one another with soll-free contact numbers for such purposes.
- F. Utilicore Corporation will contact the appropriate repair centers in accordance with procedures established by the Company.
- G. For all repair requests, Utilicore Corporation accepts responsibility for adhering to the Company's prescreening guidelines prior to referring the trouble to the Company.
- FI. The Company will bill Utilicore Corporation for handling troubles that are found not to be in the Company's network pursuant to its standard time and meterial charges. The standard time and meterial charges will be no more than what BellSouth charges to its retail customers for the same services.
- The Company reserves the right to contact Utilicore Corporation's customers, if deemed necessary, for maintenance purposes.

VI. Establishment of Service

- A. After receiving certification as a local exchange company from the appropriate regulatory agency,
 Utilicore Corporation will provide the appropriate Company service center the necessary documentation
 to enable the Company to establish a master account for Utilicore Corporation. Such documentation shall
 include the Application for Master Account, proof of withority to provide telecommunications services,
 an Operating Company Number ("OCN") assigned by the National Exchange Carriers Association
 ("NECA") and a tax exemption certificate, if applicable. When necessary deposit requirements are met,
 the Company will begin taking orders for the resale of service.
- B. Service orders will be in a standard format designated by the Company.
- C. When notification is received from Utilicore Corporation that a current customer of the Company will subscribe to Utilicore Corporation's service, standard service order intervals for the appropriate class of service will apply.
- D. The Company will not require end user confirmation prior to establishing service for Utilicore Corporation's end user customer. Utilicore Corporation must, however, be able to demonstrate end user authorization upon request.
- E. Utilicore Corporation will be the single point of context with the Company for all subsequent ordering activity resulting in additions or changes to resold services except that the Company will accept a request directly from the end user for conversion of the and user's service from Utilicore Corporation to the Company or will accept a request from another OLEC for conversion of the end user's service from Utilicore Corporation to the other LEC. The Company will notify Utilicore Corporation that such a request has been processed.

- F. If the Company determines that an unauthorized change in local service to Utilicore Corporation has occurred, the Company will reestablish service with the appropriate local service provider and will assess Utilicore Corporation as the OLEC initiating the unauthorized change, the unauthorized change charge described in F.C.C. Tariff No. 1, Section 13. Appropriate nonrecurring charges, as set forth in Section A4. of the General Subscriber Service Tariff, will also be assessed to Utilicore Corporation. These charges can be adjusted if Utilicore Corporation provides satisfactory proof of authorization.
- G. In order to safeguard its interest, the Company reserves the right to secure the account with a suitable form of security deposit, unless satisfactory credit has already been established.
 - Such security deposit shall take the form of an irrevocable Lotter of Credit or other forms of security acceptable to the Company. Any such security deposit may be held during the continuance of the service as security for the payment of any and all amounts accruing for the service.
 - If a security deposit is required, such security deposit shall be made prior to the inauguration of service.
 - 3. Such socurity deposit may not exceed two months' estimated billing.
 - 4. The fact that a security deposit has been made in no way relieves Utilicore Corporation from complying with the Company's regulations as to advance payments and the prompt payment of bills on presentation nor does it constitute a waiver or modification of the regular practices of the Company providing for the discontinuance of service for non-payment of any sums due the Company.
 - The Company reserves the right to increase the security deposit requirements when, in its sole judgment, circumstances so warrant and/or gross monthly billing has increased beyond the level initially used to determine the security deposit.
 - In the event that Utilicare Corporation defaults on its account, service to Utilicare Corporation
 will be terminated and any security deposits held will be applied to its account.
 - 7. In the case of a cash deposit, interest at a rate as set forth in the appropriate BellSouth tarriff shall be paid to Utilicore Corporation during the continuance of the security deposit. Interest on a security deposit shall accrue annually and, if requested, shall be annually credited to Utilicore Corporation by the accrual date.

VII. Payment And Billing Arrangements

- A. When the initial service is ordered by Utilicore Corporation, the Company will establish an accounts receivable master account for Utilicore Corporation.
- B. The Company shall bill Utilicore Corporation on a current basis all applicable charges and credits.
- C. Payment of all charges will be the responsibility of Utilicore Corporation. Utilicore Corporation shall make payment to the Company for all services billed. The Company is not responsible for payments not received by Utilicore Corporation from Utilicore Corporation's customer. The Company will not become involved in billing disputes that may arise between Utilicore Corporation and its customer. Payments made to the Company as payment on account will be credited to an accounts receivable master account and not to an end user's account.

- D. The Company will render bills each month on established bill days for each of Utilicore Corporation's accounts.
- E. The Company will bill Utilicore Corporation, in advance, charges for all services to be provided during the ensuing billing period except charges associated with service usage, which charges will be billed in arrears. Charges will be calculated on an individual and user account level, including, if applicable, any charges for usage or usage allowances. BellSouth will also bill all charges, including but not limited to 911 and E911 charges, telecommunications relay charges, and franchise floor, to Utilicore Corporation.
- F. The payment will be due by the next bill date (i.e., same date in the following month as the bill date) and is payable in immediately available funds. Payment is considered to have been made when received by the Company.
 - If the payment due date falls on a Sunday or on a Holiday which is observed on a Monday, the
 payment due date shall be the first non-Holiday day following each Sunday or Holiday. If the
 payment due date falls on a Senarday or on a Holiday which is observed on Tuesday, Wednesday,
 Thursday, or Friday, the payment due date shall be the last non-Holiday day preceding such
 Sanarday or Holiday. If payment is not received by the payment due date, a late payment penalty,
 as set forth in I. following, shall easily.
- G. Upon proof of tax exempt certification from Utilicore Corporation, the total amount billed to Utilicore Corporation will not include any taxes due from the end user. Utilicore Corporation will be solely responsible for the computation, tracking, reporting and payment of all federal, state and/or local jurisdiction taxes associated with the services resold to the and user.
- H. As the customer of record, Utilicore Corporation will be responsible for, and remit to the Company, all charges applicable to its resold services for emergency services (E911 and 911) and Telecommunic; tions Relay Service (TRS) as well as any other charges of a similar nature.
- If any portion of the payment is received by the Company offer the payment due date as set forth preceding, or if any portion of the payment is received by the Company in funds that are not immediately available to the Company, then a late payment penalty shall be due to the Company. The late payment penalty shall be the portion of the payment out received by the payment due date times a late factor. The late factor shall be as set forth in Section A2 of the General Subscriber Service Tariff and Section B2 of the Private Line Service Tariff.
- J. Any switched access charges associated with interexchange carrier access to the resold local exchange lines will be billed by, and due to, the Company. No additional charges are to be assessed to Utilicore Corporation.
- K. The Company will not perform billing and collection services for Utilicore Corporation as a result of the execution of this Agreement. All requests for billing services should be referred to the appropriate entity or operational group within the Company.
- L. Pursuant to 47 CFR Section 51.617, the Company will bill Utilicore Corporation and user common line charges identical to the end user common line charges the Company bills in and users.
- M. In general, the Company will not become involved in disputes between Utilicore Corporation and Utilicore Corporation's end user customers over resold services. If a dispute does arise that cannot be settled without the involvement of the Company, Utilicore Corporation shall contact the designated Service Canter for resolution. The Company will make every effort to assist in the resolution of the dispute and will work with Utilicore Corporation to resolve the matter in as timely a manner as possible. Utilicore Corporation may be required to substitute to substantiate the claim.

VIII. Discontinuance of Service

- A. The procedures for discontinuing service to an end user are as follows:
 - Where possible, the Company will deny service to Utilicore Corporation's end user on behalf of, end at the request of, Utilicore Corporation. Upon restoration of the end user's service, restoral charges will apply and will be the responsibility of Utilicore Corporation.
 - At the request of Utilicore Corporation, the Company will disconnect a Utilicore Corporation and user customer.
 - All requests by Utilicore Corporation for denial or disconnection of an end user for nonpayment must be in writing.
 - Utilicore Corporation will be made solely responsible for notifying the end user of the proposed disconnection of the service.
 - 5. The Company will continue to process calls made to the Annoyance Call Center and will advise Utilicore Corporation when it is determined that annoyance calls are originated from one of their end user's locations. The Company shall be indemnified, defended and held harmless by Utilicore Corporation and/or the end user against any claims, loss or damage arising from providing this information to Utilicore Corporation. It is the responsibility of Utilicore Corporation to take the corrective action necessary with its customers who make annoying calls. Failure to do so will result in the Company's disconnecting the and user's service.
- B. The procedures for discontinuing service to Utilicore Corporation are as follows:
 - The Company reserves the right to suspend or terminate service for nonpayment or in the event of prohibited, unlawful or improper use of the facilities or service, abuse of the facilities, or any other violation or noncompliance by Utilicore Corporation of the rules and regulations of the Company's Tariffs.
 - 2. If payment of account is not received by the bill day in the month after the original bill day, the Company may provide written notice to Utilicore Corporation, that additional applications for service will be refused and that any pending orders for service will not be completed if payment is not received by the fifteenth day following the date of the notice. If the Company does not refuse additional applications for service on the date specified in the notice, and Utilicore Corporation's noncompliance continues, nothing contained herein shall preclude the Company's right to refuse additional applications for service without further notice.
 - If payment of account is not received, or arrangements made, by the bill day in the second
 consecutive month, the account will be considered in dafault end will be subject to denial or
 disconnection, or both.
 - 4. If Utilicore Corporation fails to comply with the provisions of this Agreement, including any payments to be made by it on the dates and times herein specified, the Company may, on thirty days written notice to the person designated by Utilicore Corporation to receive notices of noncompliance, discontinue the provision of existing services to Utilicore Corporation at any time thereafter. In the case of such discontinuance, all billed charges, as well as applicable termination charges, shall become due. If the Company does not discontinue the provision of the services involved on the date specified in the thirty days notice, and Utilicore Corporation's noncompliance.

continues, nothing contained herein shall preclude the Company's right to discontinue the provision of the services to Utilicore Corporation without further notice.

- 5. If payment is not received or arrangements made for payment by the date given in the writing notification, Utilizore Corporation's services will be discontinued. Upon discontinuance of service on a Utilizore Corporation's account, service to Utilizore Corporation's and users will be desired. The Company will also reestablish service at the request of the end user or Utilizore Corporation upon payment of the appropriate connection for and subject to the Company's normal application precedures. Utilizore Corporation is solely responsible for notifying the end user of the proposed disconnection of the service.
- If within fifteen days after an end user's service has been desied no contact has been made in reference to restoring service, the end user's service will be disconnected.

IX. Liability

- A. The liability of the Company for damages arising out of mistakes, omissions, interruptions, preemptions, delays errors or defects in transmission, or fallers or defects in facilities farnished by the Company, occurring in the course of furnishing service or other facilities and not caused by the negligence of Utilicore Corporation, or of the Company in failing to maintain proper standards of maintenance end operation and to exercise reasonable supervision shall in no event exceed an amount equivalent to the proportionate charge to Utilicore Corporation for the period of service during which such mistake, omission, interruption, preemption, delay, error or defect in transmission or defect or failure in facilities occur. The Company shall not be liable for damage arising out of mistakes, omission, interruptions, preemptions, delays, errors or defects ir transmission or other injury, including but not limited to injuries to persons or property from voltages or currents transmitted over the service of the Company, (1) caused by customer-provided equipment (except where a contributing cause is the maifunctioning of a Company-provided connectional amount of the Company billing for the period of service during which such mistake, omission, interruption, preemption, delay, error, defect in transmission or injury occurs), or (2) not prevented by customer-provided equipment but which would have been prevented had Company-provided equipment been used.
- B. The Company shall be indemnified end saved harmless by Utilicore Corporation against any and all claims, actions, causes of action, damages, liabilities, or demands (including the costs, expenses and reasonable attorneys' flees, on account thereof) of whatever kind or nature that may be made by any third party as a result of the Company's furnishing of service to Utilicore Corporation.
- C. The Company shall be indemnified, defended end held harmless by Utilicore Corporation and/or the end user against any claim, loss or damage arising from the use of services offered for resale involving:
 - Claims for liftet, stander, investes of privacy or infringement of copyright arising from Utilicore Corporation's or end user's own communications.
 - Claims for patent infringement arising from acts combining or using Company services in connection with facilities or equipment furnished by the end user or Utilicore Corporation.
 - All other claims arising out of an act or omission of Utilicore Corporation or its and user in the course of using services.

D. Utilicore Corporation accepts responsibility for providing access for maintenance purposes of any service resold under the provisions of this Tariff. The Company shall not be responsible for any failure on the part of Utilicore Corporation with respect to any end user of Utilicore Corporation.

X. Treatment of Proprietary and Confidential Information

- A. Both parties agree that it may be necessary to provide each other during the term of this Agreement with certain confidential information, including trade secret information, including but not limited to, technical and business plans, technical information, proposals, specifications, drawings, precedures, customer account data and like information (hereinelier collectively referred to as "information"). Both parties agree that all information shall either be in writing or other tangible format and clearly marked with a confidential, private or proprietary legand, or, when the information is communicated emily, it shall also be communicated that the information is confidential, private or proprietary. The information will be returned to the owner within a reasonable time. Both parties agree that the information shall but be copied or reproduced in any form. Both parties agree to receive such information and not disclosure or dissemination. Both parties agree to protect the information received from distribution, disclosure or dissemination to anyone except employees of the parties with a need to know such information and which employees agree to be bound by the terms of this Section. Both parties will use the same standard of care to protect information received as they would use to protect their own confidential and proprietary information.
- B. Notwithstanding the foregoing, both parties agree that there will be no obligation to present any portion of the information that is either: 1) made publicly available by the owner of the information or lawfully disclosed by a nonparty to this Agreement; 2) lawfully obtained from any source other than the owner of the information; or 3) previously known to the receiving party without an obligation to keep it confidential.

XI. Resolution of Disputes

Except as otherwise stated in this Agreement, the parties agree that if any dispute arises as to the interpretation of any provision of this Agreement or as to use proper implementation of this Agreement, either Party may petition the Commission for a resolution of the dispute. However, each party reserves any rights it may have to seek judicial review of any rating made by the Commission concerning this Agreement.

XIL. Limitation of Use

The parties agree that this Agreement shall not be proffered by either party in another jurisdiction as evidence of any concession or as a waiver of any position taken by the other party in that jurisdiction or for any other purpose.

XIIL Walvers

A failure or delay of either Party to enforce any of the provisions hereof, to exercise any option which is herein provided, or to require performance of any of the provisions hereof shell in no way be construed to be a waiver of such provisions or options, and such Party, notwithstanding such failure, shell have the right thereafter to insist upon the specific performance of any and all of the provisions of this Agreement.

XIV. Governing Law
