**Re: Docket No. 980616-WU - Tariff filing for new customer classification for 1" meter by County-Wide Utility Co., Inc. in Marion County**

Dear Mr. Leeward:

Staff has received your request for approval of the tariff filing dated May 1, 1998, concerning a new customer classification for a 1" meter. In order to analyze your request, we need some additional information concerning the tariff sheet you provided.

1. What is the average monthly water consumption (usage) for the residential customers?
2. How much is the customer going to be charged since the customer has been hooked up and the anticipated billing date is June 1, 1998?
3. In the tariff sheet provided for the 5/8"x 3/4" meter, the thresholds of the three tiers are 3,700 gallons, 18,800 gallons, and any usage above 18,800 gallons. However, in your current effective tariff sheet, the thresholds of the three tiers are 3,751 gallons, 22,500 gallons, and any usage above 22,500 gallons. Provide justification for the proposed changes of the current approved thresholds.
4. Provide the calculation and justification of the 9,400 gallons and 46,800 gallons thresholds of the tiers for the 1" meter.
5. If the tariff sheet has to be suspended, would you agree to collect the revenue subject to refund if the rates charged to the customers are different from the final rates approved?


