

Dear Ms. Bayo:

Comcast Long Distance, Inc. ("CLD") has been authorized by the Commission to provide its intrastate interexchange service (Certificate No. 5213, issued September 15, 1997).

CLD has determined that it is no longer desirable to continue to provide interexchange service in Florida. Pursuant to the suggestion of the Commission staff, CLD is hereby notifying the Commission that it will discontinue providing intrastate service in Florida effective July 25, 1998. CLD holds no customer deposits for customers in Florida and its revenue from intrastate service in the state of Florida for 1997 was less than \$5.00. Although CLD is terminating its service in the state of Florida, an affiliated company, Comcast Telecommunications, Inc. ("CTI") also holds an authorization to provide interexchange service in Florida (Certificate No. 3545). CTI will continue to provide interexchange service in Florida and intends to operate doing business as Comcast Long Distance subsequent to CLD's termination of service in the state.

To the extent necessary, CLD also hereby respectfully requests that CLD's current tariff be cancelled effective July 25, 1998.
