Dear Ms. Stone:

Staff and Legal counsel have reviewed your application for amendment of certificate number 363-W. In order for your application to be in compliance with Section 367.045 Florida Statutes, the following deficiencies will need to be corrected:

- (1) A copy of an official county tax assessment map or other map showing township range and section with scale is required.
- (2) A copy of a detailed system map showing the proposed lines, treatment facilities, and the territory proposed to be served. The map shall be of sufficient scale and detail to enable correlation with the description of the territory.
- (3) A statement describing the capacity of the existing lines, the capacity of the existing treatment facilities, and the design capacity of the proposed extension.
- (4) A detailed statement regarding the proposed method of financing the construction, and the projected impact on the utility's capital structure.
- (5) A statement regarding the projected impact of the extension on the utility's monthly rates and service availability charges.
- (6) List the population present of each area to be added.
- (7) List the potential population at buildout of each area to be added.


