In Order PSC-97-1311-FOF-TI in Docket No. 970385-TI, dated October 22, 1997, the Commission granted Sprint Spectrum L.P. ("Sprint Spectrum") authority to provide resold interexchange telecommunications services. Since that date, Sprint Spectrum has determined that its current business plan does not require the type of authority granted in the aforementioned Order. Therefore, Sprint Spectrum respectfully requests that the Commission cancel Sprint Spectrum's authority to provide interexchange services and its associated Florida PSC tariff.
