
The Application in the above-referenced case was filed by Hydratech Utilities, Inc. in order to provide bulk wastewater service to an area known as the Banner Lake Subdivision which was being retro-fitted for central sewer service by Martin County. The Utility had planned to work with Martin County to provide bulk wastewater service so that Martin County would be primarily responsible for operation maintenance of the internal distribution collection system. As a result of recent discussions with Martin County over the last several months, Martin County and Hydratech Utilities, Inc. have now entered into an Agreement whereby Hydratech Utilities, Inc. will provide individual service within the Banner Lake subdivision. As such, there is no further need for approval of a bulk service rate for Hydratech Utilities, Inc.

As a result of the above facts, please consider this letter to be Hydratech's withdrawal of its request for approval of a bulk service rate and, as such, a request to close this docket.
