CASE BACKGROUND

Sprint Payphone Services, Inc. (Sprint) requested incoming call waivers for 76 pay telephones at Kwik King stores in the Ocala area. Each of the requests was submitted on a properly completed Form PSC/CMU 2 (12/94). After further investigation, Sprint notified the Commission that it was requesting that the waiver petitions be withdrawn.

DISCUSSION OF ISSUES

ISSUE 1: Should the Commission acknowledge Sprint Payphone Services, Inc.'s request to withdraw its petitions for a waiver from the requirement that each telephone station shall allow incoming calls for the Kwik King pay telephones in the Ocala area?

RECOMMENDATION: Yes. (Isler)

STAFF ANALYSIS: On April 27 and 30, 1998, Sprint Payphone Services, Inc. filed petitions requesting a waiver from the requirement that each telephone station allow incoming calls for 76 pay telephones at Ocala area Kwik Kings.

After further investigation, on August 7, 1998, Sprint requested that its petitions be withdrawn (ATTACHMENT A). Therefore, staff recommends that the Commission acknowledge Sprint's request to withdraw its petitions.

ISSUE 2: Should these dockets be closed?
