Lake Utility Services, Inc. (LUSI) gives notice that it:

1. Withdraws its Offer of Settlement dated September 17, 1997. This action moots Order No. PSC-98-0683-AS-WU (Notice of Proposed Agency Action Order Accepting Settlement Offer) issued May 18, 1998, moots the Office of Public Counsel's protest of that PAA Order, and eliminates the need for the hearing currently scheduled for September 15-16, 1998.

2. Withdraws its protest dated May 30, 1997 to Order No. PSC-97-0531-FOF-WU (Notice of Proposed Agency Order Approving, In Part, and Denying, In Part, Increased Rates and Charges). This action allows Order No. PSC-97-0531-FOF-WU to become effective and final on the date of this notice.

3. LUSI will file appropriate customer notices and tariff sheets for approval by the Commission, and will commence a partial refund of interim rates, in compliance with Order No.

PSC-97-0531-FOF-WU, as quickly as possible.
