
Dear Ms. Bayo:

Tampa Electric Company submits the following corrections to typographical errors contained in its August 28, 1998 Request for Specified Confidential Treatment:

1. On page 2 of the Request for Specified Confidential Treatment, at line 4, the date December 31, 2001 should be changed to read December 31, 2000.
2. On page 6 of the detailed justification the 6th line reference (even numbers from 4 through 28) needs to have the 9 in that list changed to a 10.
3. On page 8 of the detailed justification the 2nd Line No. reference (4, 5, 8, 11-13 and 15) should have the 5 converted into a 6, so that the reference reads 4, 6, 8, 11-13, 15.
4. On page 8 of the detailed justification the 6th Line No. reference (13, 15, 16, 19) should have the number 17 inserted, so that the reference reads 13, 15, 16, 17, 19.


