4. On November 24, 1997, the Commission issued its Order¹ approving a joint petition by Tampa Electric and Lakeland to allow the city to provide temporary electric service to Tenorock Fish and Game Preserve ("Tenorock"). As the Commission Order stated, under the Territorial Agreement between Tampa Electric and Lakeland approved by the Commission in Order No. PSC-92-0570-FOF-EU, issued June 25, 1992, Tenorock is located within Tampa Electric's service area.

5. In approving the temporary power service arrangement, the Commission required that Lakeland and Tampa Electric return to the Commission for further review of the temporary power service arrangement and possible modification of the Territorial Agreement if Tampa Electric had not begun providing permanent electric service to Tenorock by April 30, 1998.

6. After carefully considering the temporary service arrangement, the relative economics and logistics of Tampa Electric, as opposed to Lakeland, providing service to the Tenorock site and other relevant considerations, Tampa Electric and Lakeland have concluded that it would be more appropriate for Lakeland to continue providing electric service to the Tenorock site on a permanent basis. Accordingly, Tampa Electric and Lakeland have entered into the attached Amendment to their existing Commission approved Territorial Agreement ("the Amendment") with such amendment being subject to and conditioned upon the approval of this Commission.

7. Pursuant to Fla. Admin. Code, Rule 25-6.0440, the Amendment contains a map and written description of the area in question. There are no terms or conditions pertaining to implementation of the Amendment other than as stated in the Amendment. The only customer affected is Tenorock which will continue to be served by Lakeland. No customers will be transferred as Tenorock is already being served by Lakeland. Tenorock has been contacted and the difference between Lakeland's rates and Tampa Electric's rates have been explained. Tenorock agrees to continue receiving electric service from Lakeland.

WHEREFORE, the parties jointly petition the Commission to approve the attached Amendment.

AMENDMENT TO TERRITORIAL AGREEMENT

THIS AMENDMENT TO TERRITORIAL AGREEMENT ("Amendment") is made and entered into this <u>17th</u> day of <u>August</u>, 1998, by and between THE CITY OF LAKELAND, a Florida municipal corporation ("Lakeland"), and TAMPA ELECTRIC COMPANY, a private Florida corporation ("TEC"). Collectively, LAKELAND and TEC will be referred to herein as the "Parties."

WHEREAS, pursuant to the approval of the Florida Public Service Commission ("FPSC") in Docket No. 920251-EU, Joint Petition of Tampa Electric Company and The City of Lakeland for Approval of Territorial Agreement, TEC and Lakeland are Parties to an FPSC approved territorial agreement dated May 20, 1991 ("the Agreement"); and


WHEREAS, Article I of the Agreement defines the respective territories of the Parties, and

WHEREAS, pursuant to Order No. PSC-97-1485-FOF-EU, Docket No. 970999-EU, TEC and Lakeland have requested from and received approval of the FPSC for Lakeland temporarily to serve a customer in TEC's service territory and to return to the FPSC in certain events relating to that service to effect an adjustment of their respective territories.

NOW THEREFORE, the Parties hereby amend the Agreement as follows:

- The Parties agree, subject to the approval of the FPSC, the lands described and depicted as "Subject Area" in the map attached hereto as Exhibit A hereby and hereinafter shall be deleted from the TEC Territorial Area and added to the Lakeland Territorial Area.
- 2. The Parties agree, subject to the approval of the FPSC, that the territorial boundary between their respective areas, as recited in Exhibit A of the Agreement, is hereby amended by including within the metes and bounds description contained in Exhibit A of the Agreement, and at the place within said metes and





3. All other provisions of the Agreement shall remain in full force and effect.



thence departing said Southerly limited access right of way boundary and on the East boundary of said Range 24 East

....proceed in a Southerly direction to the intersection of said East boundary with the centerline of the former Seaboard Coastline Railroad right of way; thence Northeasterly along said centerline to an intersection with the East boundary of the West ½ of the Northwest ¼ of Section 30, Township 27 South, Range 25 East; thence departing said centerline, proceed South along said East boundary to the South boundary of the Northwest ¼ of said Section 30; thence West along the South boundary of the Northwest ¼ of said Section 30; thence West along the South boundary of the Northwest ¼ of said Section 30 to the East boundary of Section 25, Township 27 South, Range 24 East; thence on the East boundary of said Range 24 East,....
