Dear Mr. Small:

The purpose of this letter is to provide Sprint-Florida's claim of confidentiality for FPSC Document Request No. FL-05, containing fourteen pages of confidential information. This documentation was provided in response to the Florida Public Service Commission's verification of cost data and analysis provided as required by the FPSC pursuant to Ch. 98-277, Laws of Florida. Pursuant to Section 364.183(1), Fla. Stat. this information is deemed confidential to the extent that Sprint-Florida claims that it is confidential.

This letter is also provided in response to the letter of September 11, 1998 from Jeffery Small to Judy Kohli advising that confidential treatment must be requested within 21 days in order to preserve the temporary confidentiality afforded the information during the pendency of the staff field work in Special Project 980000A-SP.

Because the subject materials are produced pursuant to a Commission requirment, the provisions of Rule 25-22.006, F.A.C. do not apply with regard to the requirement that materials be highlighted and a justification submitted. Rather, as provided by statute, since the information is required to be filed by the Commission pursuant to the Legislative study, the claim of confidentiality is all that is required to maintain confidential status. In any event, this letter operates to continue our claim and to provide the justification for continued confidentiality.
