The information further indicates, that although Florida Water Services Corporation (FWSC) appears to have the financial ability to serve, it is unclear whether FWSC will have the capacity to serve the requested area. The final determination of whether it is in the public interest to grant either Lake Suzy's or FWSC's

application cannot be made until the evidence presented at hearing is analyzed.

# D. <u>Issues of Fact, Law and Policy</u>

The following are issues identified by Staff and its positions on these issues. Staff's positions are preliminary, are based upon materials filed by the parties or obtained through discovery and are intended to inform the parties of Staff's preliminary positions. Staff's final positions will be based upon an analysis of the evidence presented at the hearing.

**ISSUE 1:** Are Lake Suzy's water and wastewater facilities and land functionally related to each other such that they constitute a single system whose service transverses county boundaries?

**POSITION:** Yes, Lake Suzy's wastewater facilities are functionally related to its water facilities, both operationally and administratively. These facilities will constitute a single system whose service transverses county boundaries if the Commission grants Lake Suzy's application.

**ISSUE 2:** Is there a need for service in the areas Lake Suzy and FWSC seek to add to their certificates and when will service be required?

**POSITION**: Yes, there is a need for service, and it appears that the need for service is immediate.

**ISSUE 3:** Does Lake Suzy/FWSC have the financial ability to serve the requested territory?

**POSITION**: Yes, it appears that both Lake Suzy and FWSC have the financial ability to serve the requested territory.

**ISSUE 4:** Does Lake Suzy/FWSC have the plant capacity/technical ability to serve the requested territory?

<u>POSITION</u>: Yes, Lake Suzy has both the capacity and technical ability to serve the requested territory. It appears that FWSC has the technical ability to serve the area, but it is unclear at this time if FWSC has the capacity to serve the area pursuant to its

bulk service agreement with Charlotte County due to a financial, as well as a contract interpretation, dispute with Charlotte County. Furthermore, no other contractual arrangements for capacity via other bulk service agreements have been provided by FWSC at this time.

**ISSUE 5:** Does water and wastewater service exist from other sources within geographical proximity to the areas Lake Suzy/FWSC seek to add to their PSC certificates?

**POSITION:** Yes, Lake Suzy, FWSC, and Charlotte County Utilities are all service providers located within geographical proximity to the requested territory.

**ISSUE 6:** Would the granting to Lake Suzy/FWSC of the territory which they seek to add, result in an extension of a system which would be in competition with or a duplication of any other system or a portion of a system?

**POSITION:** No competition or duplication will exist regardless of which utility serves the territory because none of the utilities have any physical facilities in place in the disputed area. Because Lake Suzy improperly began serving one customer in the requested area without antecedent Commission approval, it would be improper to consider these facilities in making the competition/duplication analysis.

**ISSUE 7**: What are the applicable monthly service rates, AFPI charges and service availability charges that will apply to customers if served by FWSC, Lake Suzy, or Charlotte County Utilities?

**POSITION:** The applicable rates and charges for each utility are set forth below.
