If the Commission's order is not protested and the fine and regulatory assessment fees, including statutory penalties and interest, are not received, the pay telephone certificates listed on page 6 should be canceled.

APPROVED (with the exception of Docket the 98/191-70 which was degened.)

Issue 2: Should these dockets be closed?

<u>Recommendation</u>: Yes. If no person whose substantial interests are affected files a protest within 21 days of the issuance date of the order, the order will become final. Upon payment of the fines and fees, or cancellation of the certificate, these dockets should be closed.
