Dear Ms. Bayo:

In accordance with Chapter 25-6.018 of the Florida Administrative Code, I am submitting a report on the interruptions of Florida Power & Light Company's (FPL) Commercial/Industrial Load Control (CILC), Interruptible Standby and Supplemental (ISST), and Curtailable (CS) customers' load. The report includes three attachments, described below. Because the report contains certain customer-specific information that FPL seeks to maintain as confidential, only non-confidential versions of the attachments are provided herewith. Complete copies of the attachments that include the confidential information are being provided to the Commission this day under separate cover in connection with FPL's Request for Confidential Classification.

Attachment I provides a list of CILC and ISST customers interrupted system wide in June in order to offset heavy power demands and a capacity shortage resulting from hot weather. The control period was as follows:


