Public Service Commissioners RE: Public Meeting held at the Haines City Hall 502 Hinson Avenue

Please refer to the news article published in The Ledger, Sunday, January 19, 1997 by Lonnie Brown. In that article he refers to the area of Polk County known as the Ridge. Haines City is in this area discussed in the article. Mr. Brown indicated that computer owners in this area have been unable to log on-line with major providers such as America-on-Line unless they pay an extra fee or toll charges. He continues that, before December 1996, there were over 7,000 computer users in this area of the Ridge. I have written letters to each of the major providers concerning this problem of "being out of the area". A copy of * letter from Prodigy is included wherein they confirm that we are unable to directly access their service without extra charges.

I use a beeper from MobileComm, a BellSouth Company, for business matters Even though they are one of the largest communication providers, my service can not be called direct from my home with out long-distance charges because the nearest MobileComm beeper number is out of Lakeland. It forces an extra expense should my family need to contact me when I am away from home.

Last year, Congress adopted the Telecommunications Act of 1996. Section 207 directed the Federal Communications Commission to adopt rules that permit every home in the United States the access to TV and communications even if they were prohibited by existing covenants and restrictions. While this Section does not directly address the phone coverage that is under consideration by this Commission, the intent is strong in that Congress wants all citizens to have the right to open communications.

Under the current service, we have been denied direct access to our County Government, services and businesses of our choice, and communications via our computer without paying extra service costs. Even with the plan under proposed today, we would have the service at an extra cost but more reasonable charges. I suggest that you consider the plan to extend the service to Bartow and Lakeland as an extension of the current service from the Ridge.

That's nice to have if you're traveling and are in an area that doesn't tave a local connect number flut if you're a full-time resident without a local number connecting frequently at \$3 an hour - plus paying a monthly bill to maintain an online account — can become expensive There is no local rull number for these online services on the Hidge, said Myers. He also pointed out that many of the larger Internet service providers, including AT&T and GTE, do not have a local number to connect.

We sincerely regret you are currently unable to access Prodigy with a local telephone number Prodigy is available as a local call to a large majority of our members. We would like to offer local access number to all of our current and potential members, and we are continually adding or updating our access numbers.

Each of our access numbers requires a significant investment by Prodigy in leased telephone lines and acquisition of an access site. For these reasons we must be prudent when selecting rives Currently we use Census Bureau population density statistics, as well as independent market research data for PC market penetration. Our site selections are the result of analyzing these studies. This results in a small percentage of American households who are currently able to access only through a toll call. Many people are active members even under these circumstances, by using off-peak periods with lower toll charges

It may interest you to know Prodigy is currently negotiating with local phone companies around the nation to make the service more accessible to our members. The TELECOMMUNICATIONS ACT OF 1996 SECTION 207

Which directed the Federal Communications Commission (FCC) to adopt rules on restriction on Over-the Air Reception Devices.

Within 180 days after the date of enactment of the Act, the Commission shall, pursuant to Section 303 of the Communication Act, promulgate regulations to prohibit restrictions that impair a viewers ability to receive video programming services through devices designated for over-the-air reception of television broadcast signals, multi-channel multi-point distributions service, or direct broadcast satellite services.

The FCC has now adopted such a rule which became effective on October 14, 1996.

The Act is a comprehensive legislative initiative that changes the telecommunication's industry in many ways. The Act is designed to ultimately benefit consumers of communication, computer, entertainment and business s rvices.
