1. On April 25, 1997, Telephone Company of Central Florida, Inc. ("TCCF") executed a Confidential Full Release and Settlement Agreement. The Florida Public Service Commission Staff has requested a copy of that Agreement.

2. As part of the terms of the Agreement, BellSouth and TCCF agreed not to disclose any of the terms and conditions of the Full Release and Settlement.

3. BellSouth has appended to this Request for Confidential Classification as Attachment A an identification of the location of the specific information for which confidential classification is requested.

4. BellSouth has appended to this Request as Attachment B a redacted paper copy of the information for which confidential classification is requested.


5. BellSouth has appended to this Request as Attachment C a highlighted paper copy of the information for which confidential classification is requested.
