## LEAF'S RESPONSE TO TAMPA ELECTRIC COMPANY'S MOTION FOR A PROTECTIVE ORDER

Pursuant to Rule 28-106.204, FAC, Legal Environmental Assistance Foundation, Inc. ("LEAF") files this response to Tampa Electric Company's ("TECO's") Motion for a Protective Order and states:

1. LEAF will continue to work with TECO in an effort to resolve the issues raised in TECO's Objections, Motion for a Protective Order, and Written Response to LEAF's Second Set of Interrogatories and Second Request for Production of Documents (hereinafter "TECO's filing") Though such effort is ongoing, Rule 28-106.204, FAC, requires LEAF to respond to written motions within seven days or risk Commission action without LEAF's input.

2. Under the title "Motion for a Protective Order," Paragraph 9 of TECO's Filing states that "to extent that a Motion for a Protective Order is required, Tampa Electric's objections are to be construed as a request for a Protective Order."

3. To the extent the aforesaid paragraph constitutes a motion for a protective order LEAF objects to the issuance of any such order in that; the subject interrogatories and document production requests are relevant, sufficiently clear, reasonably calculated to lead to the discovery of admissible evidence, and permissible under the Florida Rules of Civil Procedure and Florida law; neither the action requested nor the grounds therefore have been fully or sufficiently stated; and TECO's claims of privilege do not contain sufficient disclosure to enable assessment of their applicability.

WHEREFORE, LEAF asks that the Commission deny TECO's Motion for a Protective Order.
