ORDER CORRECTING ORDERS NOS. PSC-94-0992-FOF-WS
AND PSC-94-0992A-FOF-WS TO REFLECT ACCURATE
TERRITORY DESCRIPTION, AND CLOSING DOCKET

BY THE COMMISSION:

On July 15, 1993, Southern States Utilities, Inc. (now Florida Water Services Corporation), filed an application for amendment of Certificates Nos. 368-W and 319-S to include additional territory in Fisherman's Haven, Leilani Heights and Fox Run in Martin County. The Commission granted Florida Water Services Corporation (Florida Water or utility) the additional territory by Orders Nos. PSC-94-0992-FOF-WS and PSC-94-0992A-FOF-WS, issued on August 16, 1994, and August 30, 1994, respectively, in Docket No. 930699-WS. The additional territory approved by the Commission was shown on Attachment A of those Orders.

By letter dated November 12, 1998, Florida Water informed the Commission that the territory description granted by Orders Nos. PSC-94-0992-FOF-WS and PSC-94-0992A-FOF-WS was incorrect as a result of a scrivener's error. The utility discovered the error in a review of the service areas under Commission jurisdiction. When maps were compared to legal descriptions, it was discovered that the current tariffs for Leilani Heights were incorrect. Attachment A of those Orders incorrectly described the Leilani Heights

The correction does not affect any customers or add any additional area to Florida Water's certificated territory. The mistake appears to be a scrivener's error. Accordingly, we find it appropriate to correct Orders Nos. PSC-94-0992-FOF-WS and PSC-94-0992A-FOF-WS to reflect the correct territory description as shown on Attachment A of this Order, which by reference is incorporated herein. The utility provided tariff sheets reflecting the correct description.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request of Florida Water Services Corporation, Post Office Box 609520, Orlando, Florida 32860-9520, to correct the scrivener's error in the Leilani Heights territory approved by Orders Nos. PSC-94-0992-FOF-WS and PSC-94-0992A-FOF-WS is hereby granted. The Orders are hereby corrected to reflect the correct territory description as shown on Attachment A of this Order, which by reference is incorporated herein. It is further

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
