Per your request, please find attached the portion of the Commission's Comparative Cost Statistics Report that includes rate information for Commission regulated water and wastewater utilities located in Lake and Marion Counties. Regarding water rates, the report contains each utility's base rate and gallonage charge per 1,000 gallons of water, along with a calculation of a bill at 5,000 and 10,000 gallons of usage. Regarding wastewater rates, the report contains each utility's base rate and gallonage charge per 1,000 gallons of wastewater, the maximum gallonage that may be billed for residential wastewater service, and the maximum bill that may be charged to a residential wastewater customer by that utility.

You may notice that some of the utility names have a number beside them. The last page of the attachment includes the footnotes that explain the numbers. It is important to refer to these in order to make an accurate rate comparison, because some of the utilities shown do not have the same base facility charge/gallonage charge rate structure and monthly billing cycle that Shangri-La uses.
