RESOLUTION NO. 99-173

A RESOLUTION SUPPORTING DESIGNATION AND ASSIGNMENT OF A SINGLE TELEPHONE AREA CODE FOR USE IN VOLUSIA COUNTY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Public Service Commission is currently examining options regarding assignment of telephone area codes within Volusia County; and

WHEREAS, local governments within Volusia County desire the designation of a single telephone area code for use within the County; and

WHEREAS, the City Commission of The City of Daytona Beach, in cooperation with other local governments within the County, wishes to express its position to the Public Service Commission, and to participate in the Commission's decision-making process.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DAYTONA BEACH, FLORIDA:

SECTION 1. The City Commission of The City of Daytona Beach hereby expresses its strong support for the designation and assignment of a single telephone area code for use throughout Volusia County, and requests that the Public Service Commission approve the same.

SECTION 2. The City Clerk is hereby directed to provide a certified copy of this resolution to the Public Service Commission.

SECTION 3. This Resolution shall take effect immediately upon its adoption.
