Re: *Report of Service Interruption*

Dear Ms. Bayo:

Pursuant to Chapter 25-4.023 of the Commission's Rules, Teligent, Inc. ("Teligent"), hereby reports two interruptions in its Florida telecommunications services. On Wednesday, June 16, 1999, Teligent was unable to process all in-bound or out-bound calls beginning at 15:56 and ending at 22:37, due to a cut of a (200) pair of copper cable. On Friday, June 18, 1999, a second cut of a (400) pair of copper cable also occurred, resulting in Teligent's inability to process all in-bound or out-bound calls beginning at 11:38 and ending at 13:08.

Neither of these occurrences was attributable to Teligent or any of its employees. Teligent's internal investigation concluded that the outages were caused by the actions of a subcontractor hired by a Florida Power Corporation subsidiary to install fiber optic cable in the Rio Drive area. Teligent understands that, during installation, the subcontractor severed the affected cables.

Please note that Teligent is not required to report these service interruptions to the Federal Communications Commission as neither was for a period of 48 or more consecutive hours.
