PETITION OF MEDIAONE FLORIDA
TELECOMMUNICATIONS INC. FOR LEAVE TO INTERVENE

Pursuant to Rule 25-22.039, Florida Administrative Code, MediaOne Florida Telecommunications Inc. ("MediaOne") respectfully petitions the Florida Public Service Commission ("Commission") for leave to intervene in the above-captioned proceeding. In support thereof, MediaOne states as follows:

1. The petitioner, MediaOne, is a certificated Alternative Local Exchange Company ("ALEC") authorized by the Commission to operate in Florida. MediaOne's business address is 7800 Belfort Parkway, Suite 250, Jacksonville, FL 32256.

3. On December 10, 1998, the Florida Competitive Carriers Association (FCCA) and several other petitioners filed a petition for Commission action to support local competition in BellSouth's service territory. By Order dated May 26, 1999, the Commission granted the request for establishment of a Unbundled Network Element ("UNE") pricing docket. The instant Docket No. 990649-TP was opened to investigate,

among other things, the pricing of unbundled network elements, requirements to make them available and the performance of cost studies.

4. The Commission's decisions on these issues directly and materially affect MediaOne. The company is a certificated ALEC currently competing in BellSouth's territory. MediaOne offers and intends to offer competitive services that will require access to reasonably and lawfully priced UNEs of the incumbent LECs. Orders of the Commission in this proceeding will directly impact the terms by which MediaOne provides service.

WEHREFORE, MediaOne respectfully requests that the Commission grant its Petition and allow MediaOne to become a full party of record in this docket.
