PETITION

Sebring Gas System, Inc. ("Sebring" or the "Company"), by its undersigned attorneys, petitions the Commission for approval of revisions to its Natural Gas Tariff on file with the Commission to provide for a late payment charge. In support of its petition, Sebring states:

Sebring is a public utility providing natural gas to customers in and around Sebring.

- Sebring proposes to apply a late payment charge to customers' past due balances, the purpose of which is to more properly collect the costs associated with unpaid balances on customer accounts from those customers who do not pay their bills on time. Such a late payment charge should also encourage prompt payment by Sebring's customers, thereby helping Sebring reduce expenses associated with unpaid balances. From January 1998 to May 1999, the percentage of Sebring's gas customers delinquent in payment averaged 12.85%.
- 3. Sebring's approved Natural Gas Tariff does not currently include a late payment charge on past due balances. The Company's proposed late payment charge would apply when a

customer fails to pay a bill by the "past due" date indicated on the bill. The proposed late payment charge (other than for accounts of federal, state or local governmental entities) is 1.5 percent of any unpaid prior months' billings or \$5.00, whichever is greater. The excepted governmental entities are subject to imposition of a late payment charge in accordance with Section 215.422, Florida Statutes (state agencies), 218.70 - .79, Florida Statutes (local governmental agencies), and 31 U.S.C. 3901 - 3907 (federal governmental agencies), and Sebring would impose late payment charges on their accounts at a rate no greater than allowed, and in a manner permitted, by the applicable statutes.

4. In the past, late payment fee requests have been handled on a case-by-case basis. <u>In</u> re: Application for Staff-Assisted Rate Case in Osceola County by Morningside Utility, Inc., Docket No. 980445-WU, Order No. PSC-98-1585-FOF-WU (November 25, 1998). In Order No. PSC-98-1585-FOF-WU, the Commission has acknowledged the need for late payment charges; stating:

Presently, our rules provide that late paying customers may be required by the utility to provide an additional deposit. However, there is no further incentive for late paying customers to pay their bills on time. We find that the cost causer should pay the additional costs incurred to the utility by late payments, rather than the general body of the utility's rate payers.

5. The Commission has previously approved late payment charges of 1.5% of the total bill¹, and has also approved flat rate late payment charges of \$5.00.² Consistent with the prior

actions of this Commission, and for the reasons stated, Sebring requests the Commission's approval for the Company's late payment charge as set forth in the proposed revised tariff sheet (First Revised Sheet No. 9.0505) attached to this petition as Exhibit A. A copy of the proposed revised sheet in legislative format is attached hereto as Exhibit B.

Upon the Commission's approval of Sebring's proposed late payment charge, the 6. Company will modify its monthly customer bills to reflect the applicable charge and the past due date by which the bills must be paid to avoid imposition of such charge.

Sebring requests that the Commission approve this petition, and grant its Staff authority to administratively approve the effective date of First Revised Sheet No. 9.0505 to coincide with the date on which the Company's billing system will be capable of implementing and administering the late payment charge, which date is currently estimated to be October 15, 1999.

WHEREFORE, Sebring Gas System, Inc. respectfully requests that the Commission (a) approve the late payment charge set forth in Exhibit A to this petition and (b) authorize its Staff to administratively approve the effective date of the revised tariff sheet upon proper notification by the Company.
