On April 21, 1999, Order No. PSC-99-0809-AS-TC was issued, which approved your settlement offer to pay \$500 in April and \$100 installments by the last working day of each month until the \$2,500 settlement was paid in full. You failed to send in the initial \$500 on a timely basis, and in fact, the Commission did not receive it until after I called on May 21 to remind you of the late payment. The \$100 payment for May was received timely (on May 24, the same day you paid the \$500).

The third installment was supposed to have been received by the Commission by June 30. As of this date, it has not been received. A message was left at your home yesterday. July 20, with a woman who advised that she would give you the message to return Ms. Kimberly Peña's telephone call. A call has not been received.

If the Commission has not received your June and July payments by July 30 (the last working day of the month), or if any other month's payment is not received on a timely basis, staff will have no choice except to take another recommendation back to the Commissioners and recommend a \$20,000 fine for failure to comply with Order No. PSC-99-0809-AS-TC or cancellation of your pay telephone certificate.
