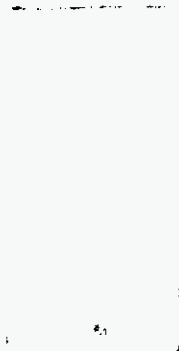
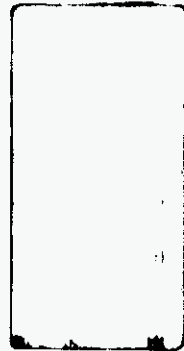
### Delinquent Notice
