This letter is to introduce you to Agent Alliance Corporation (AAC) and inform you that Bob Hiler of River City Payphones is retiring from the payphone business. AAC has assumed all rights and obligations to all of the payphones operated by Mr. Hiler as of 7/01/1999. My name is Lawrence McMillan - President of AAC. I have worked in and around the payphone business since 1980 and operated payphones in Florida since 1992. Over the next few weeks we will be analyzing and upgrading each payphone. Our goal is to provide you with the best payphone service possible.

Our standard commission checks are sent on a monthly basis approximately 45 Days after the close of each month. Since River City Payphones paid immediately after the close of each month, AAC will pay an estimated commission amount based on the past six months. You should expect this check approximately August 15, 1999. This should relieve any hardship from this change.

For semi public accounts that pay a monthly fee, we bill at the close of each month for the previous month. Therefore, August 1, 1999 bills for July 1999 and is due by September 1, 1999.
