NOTICE OF PROPOSED AGENCY ACTION ORDER DENYING CERTIFICATE TO PROVIDE INTEREXCHANGE TELECOMMUNICATIONS SERVICE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Cne Tel Inc. filed an application for a Certificate of Public Convenience and Necessity to provide statewide Interexchange Telecommunications (IXC) service. The application lacked the required tariff information to have a complete application on file with this Commission. Our staff repeatedly contacted One Tel Inc. and requested that One Tel Inc. provide this information before the application could be processed.

On June 30, 1999, our staff received a request from the One Tel Inc.'s attorney to withdraw our staff's recommendation from the July 6, 1999, Agenda Conference. Further, One Tel Inc. informed our staff that the tariff would be provided in the very near future. As of the date of this vote, One Tel Inc. has failed to submit the required information. Since this docket was opened on

November 5, 1998, we believe One Tel Inc. has had more than enough time to file a tariff. Therefore, we find that it is not in the public interest to grant a certificate, to provide interexchange telecommunications service, to One Tel Inc.

Based on the foregoing,

ORDERED by the Florida Public Service Commission that we hereby deny One Tel Inc.'s application to provide Interexchange Telecommunications service. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings" attached hereto. It is further

ORDERED that in the event this Order becomes final, this Docket shall be closed.
