**RE:** Docket No. 991268-TP; Request by BellSouth Telecommunications, Inc. for approval of resale agreement with Credit Loans, Inc. d/b/a Lone Star State Telephone Co. - Item 38

By letter dated August 31, 1999, the resale agreement between BellSouth Telecommunications, Inc. (BellSouth) and Credit Loans, Inc. d/b/a Lone Star State Telephone Co. was submitted for approval by the Commission. BellSouth faxed (at 4:09 p.m. on November 4, 1999) a letter requesting that the parties' mutually agreed upon revision be incorporated into the agreement prior to the Commission's decision to approve or reject said agreement. Since the recommendation had already been filed to meet the 90-day requirement set forth in Section 252(e)(4) of the Telecommunications Act of 1996, the parties have agreed to waive this requirement and request that Item No. 38 scheduled for the November 16 agenda conference be deferred to the November 30 agenda conference (see attached Document No. 13870-99.) Therefore, pursuant to Section 2.11B.3.b.(2), Administrative Procedures Manual, staff requests that this be handled as such.


Dear Ms. Bayo:

On August 31, 1999, BellSouth Telecommunications, Inc. and Credit Loans, Inc. d/b/a Lone Star State Telephone Co. filed their resale agreement to be approved by the Florida Public Service Commission (FPSC). On November 4, 1999, BellSouth Telecommunications, Inc. and Credit Loans, Inc. filed an amendment to their resale agreement.

In order to meet the 90-day limit pursuant to Section 252(e)(4) of the Telecommunications Act of 1996, the FPSC staff has placed the August 31, 1999 filing on the November 16, 1999 agenda conference (item # 38). However, BellSouth and Credit Loans, Inc. d/b/a Lone Star State Telephone have agreed to waive the 90 day requirement for approval of the agreement. Therefore, BellSouth requests that item number 38 scheduled for the November 16, 1999 agenda conference be deferred to the November 30, 1999 agenda conference to allow the FPSC staff time to incorporate the November 4, 1999 amendment filed in this docket.
