This is a follow up to our telephone conversation of today concerning the past due regulatory assessment fees (RAFs), including statutory penalty and interest charges. If you want to keep the pay telephone certificate active, the company must pay the past due amount in full. According to Commission records, on January 18, 1999, you paid \$9.58 for the 1998 RAFs. A minimum of \$50.00 is due each year. This leaves a balance of \$40.42 for the 1998 fee, plus \$10.11 for the penalty and \$4.04 for the interest, for a total past due of \$54.57.

In addition to paying the past due amount, if you want to keep the certificate active, the company must make a settlement offer. In other, similar cases, the Commission has accepted a \$100 settlement in lieu of the \$500 fine normally imposed for this rule violation. The settlement letter needs to include the docket number, state that it has taken steps to prevent this rule violation from happening in the future, make a specific monetary settlement, and state that the past due amount has since been paid (after you have done so, of course). 
